



# Attorney Client Agreement

## 1. Parties

The parties to this **Attorney Agreement** ("Agreement" hereinafter) is as follows;

## 2. Subject of the Agreement

The subject of this Agreement is the representation of the Client by Attorney in legal matters regarding

The scope of the Attorney's representation shall include all legal services reasonably necessary to advance the Client's interests in the matter described above, including but not limited to consultation, legal research, document drafting, negotiation, and representation in court or administrative proceedings, as applicable.

## 3. Term

The term of this Agreement begins with the client delivering the power of attorney related to the work subject to this Agreement to the Attorney and paying the attorney fee specified in this Agreement, and continues until the all related legal proceedings are finalized.

## 4. Right and Obligations of the Parties

- With this agreement, the Attorney will represent the Client in front of legal authorities and defend the Client's rights. The Attorney shall provide the necessary legal assistance and consultancy services to the Client within the scope of the determined work in accordance with the laws and professional rules.
- The Attorney agrees to provide competent and diligent legal representation to the Client, exercising the degree of skill, care, and professionalism ordinarily exercised by attorneys in similar matters. The Attorney shall keep the Client reasonably informed about the status of the matter and promptly respond to inquiries and requests for information.

- The Attorney shall constantly inform the Client about the progress of the legal proceedings and cases throughout the course of the case or the matter on which consultancy is provided, and will pay maximum attention until the end of the case and or the work being pursued, in accordance with the ethical rules.
- The Client agrees to cooperate with the Attorney and provide all information, documents, and assistance reasonably requested to facilitate the representation. The Client acknowledges that the success of the representation may depend on the Client's timely and accurate communication of relevant information.

- All taxes, fees and expenses related to litigation and business follow-up will be covered by the client.
- The addresses shown above are the notification addresses of the parties, any notifications sent by the parties to each other shall be sent to these addresses. The parties are obliged to notify the other party address changes.
- If the Client unilaterally renounces the contract, they will pay to the Attorney the attorney's fee they have undertaken under this Agreement. In this case, the Client will cover all the damages incurred and to be incurred by the Attorney. Initial payment shall not be refunded.

## **5. Confidentiality**

The Attorney and the Client acknowledge and agree that, in the course of the representation, confidential information may be disclosed by the Client to the Attorney, and vice versa. "Confidential information" shall mean any and all information, whether oral, written, or electronic, that is disclosed by one party to the other party in connection with the legal representation. The Attorney agrees to maintain the confidentiality of all information disclosed by the Client in connection with the representation, in accordance with applicable ethical rules and laws governing attorney-client privilege.

The obligations of confidentiality set forth in this Agreement shall survive the termination of the attorney-client relationship and shall continue indefinitely thereafter.

## **6. Entire Agreement**

This Agreement constitutes the entire understanding between the Attorney and the Client concerning the subject matter hereof and supersedes all prior agreements and understandings, whether written or oral.






