Terms and Conditions

- This Bartending Contract (the "Contract" hereinafter) has been signed by and between the Bartender and the Client indicated above. The Bartender is a professional bartender with certificate of _____, and the Client is seeking a professional bartender for specific invitations and events.
- The Bartender agrees and undertakes to provide bartending services at the events shall be held on every _____ at _____, during _____. The duration and scope of services to be provided in accordance with this Contract are limited to these events.
- The Bartender shall prepare and serve a variety of alcoholic and non-alcoholic beverages and cocktails as agreed upon the Client. The Bartender shall work in collaboration with other staff to keep the bar clean and tidy.
- Upon signing of this Contract, the Bartender shall submit a list of required equipment and the Client shall be responsible for setting up the bar area at the event location, including arranging all necessary equipment, glassware, garnishes, and any additional items required for the provision of bartending services.
- The Bartender shall take into consideration the legal age limit for the use of alcoholic beverages and fulfills his duty of care in this regard. In doubtful cases, the Bartender may request proof of identity.

- The Client is solely responsible for permissions and required licenses of the venue where the events will be held regarding alcohol serving and operating.
- The Bartender shall work closely with the Client to customize the beverage menu, according to the preferences of the event attendees and requirements of the event. The Bartender shall pay attention to the high quality presentation of beverages, ensuring that all drinks are visually appealing and served at the correct temperature. The Bartender shall use appropriate glassware and garnishes as necessary.
- Any additional services agreed upon between the Client and the Bartender shall be documented in writing as an annex to this Contract.
- The Client may terminate this Contract at any time by providing written notice to the Bartender. In such a case, the Client shall compensate the Bartender for services rendered up to date of termination, including any non-refundable deposits or expenses incurred by the Bartender in preparation for the event. Either party may terminate this Contract in the event of a material breach of any provision of this Contract by the other party.
- If the Bartender does not attend any of the events without a just cause, the Client may terminate the Contract unilaterally immediately. In case of being unable to attend for just cause, the Bartender has to inform the Client at least two days in advance of the situation with the reasons and, if possible show a replacement person.
- For each event day, the Bartender shall be paid _____ and _____ % of her/his sales as a bonus. Tips given to the Bartender by the event attendees belong to the Bartender.
- The Bartender is responsible for keeping the alcohol and other materials to be used in the right conditions. The Bartender cannot be held responsible for the poisoning and similar situations of the event attendees, unless it is directly caused by his/her own default.

- This Contract shall be governed by and construed in accordance with the applicable laws of the State of _____.
