- **Use of Electronic Devices:** The student agrees to follow school rules regarding the use of electronic devices, including not using them during class or at inappropriate times, and avoiding any use that could be disruptive or disrespectful to others.
- **Compliance with School Policies:** The student agrees to follow all school policies and rules, including those related to dress code, behavior, and academic standards.
- **Rewards and Consequences:** The student understands that meeting the above expectations will lead to rewards such as positive feedback, praise, or other incentives, while failing to meet them may result in consequences such as loss of privileges, detention, or other disciplinary actions.
