### **Renter's Responsibility**

It shall be the responsibility of the Renter to comply with the following:

1. The Renter shall take care of the bike in order for the next Renter to get the bike in faultless condition.
2. The Renter shall always secure the bike with a lock. It shall be the responsibility of the Biker to not ride on any lake or leave unsheltered on precipitous environments. In case of theft, the Renter agrees to pay the full bike price from our price list.
3. The Renter agrees that the bike is rented in a technically faultless condition. The Renter shall return the bike in the same condition. All defects must be reported to \_\_\_\_\_.
4. The bike is rented with the following items:

Should any of these items are lost, a fixed price of \_\_\_\_\_ shall be charged to the Renter. The final bike cleaning shall be done by \_\_\_\_\_.

5. The Renter shall be responsible for any damages due to improper use. The Renter shall be charged for the damage caused by improper use upon the return of the bike. The Renter is responsible for any damages made to a third party due to neglect or gross negligence and bears any potential costs to be incurred.

6. The repair place for the bikes of \_\_\_\_\_ is \_\_\_\_\_. Cost of the

repairs in any other than this place shall not be born by our company.

7. No personal health insurance shall be provided by \_\_\_\_\_ for an accident, fall or any other slight or severe injury, disability or death caused by riding the bike. The Renter waives all demands or claims for damage in connection with the above mentioned injuries.

8. The rental fees are fixed and in case of an early return due to bad weather or illness or when the Renter does not want to use the bike any more, no money shall be refunded.

9. If Renter returns the bicycle to the designated return area more than 20 minutes after the scheduled "Time Back," Renter shall forfeit his/her security deposit.

10. It is not allowed to sublease the bike in any case.

11. Assumption of Risk. Renter acknowledges that the activities for which the bicycle is designed include inherent dangers, including the risk of bodily injury and/or death. Renter assumes and accepts all risks associated with the use of the bicycle.

12. Renter shall not violate any of the following rules and regulations during his/her operation of the bicycle:

- There are no passengers permitted on the bicycle unless expressly permitted by \_\_\_\_\_ in writing prior to use.
- There is no smoking while on the bicycle.
- There are no alcoholic beverages permitted while using the bicycle.

### **Release Waiver**

I hereby release, quitclaim, and forever discharge the Company, its agents, officers, representatives, and employees from any and all liability or claims of illness, injury, loss or damage to property, or death resulting from my activity in riding a bicycle leased or rented from them.

I have fully and carefully read this agreement and have been afforded the opportunity to ask for

clarifications with regard to any information that is unclear to me and by which was answered to my satisfaction. I executing this agreement freely and voluntarily with full knowledge and understanding of the consequences this may incur.

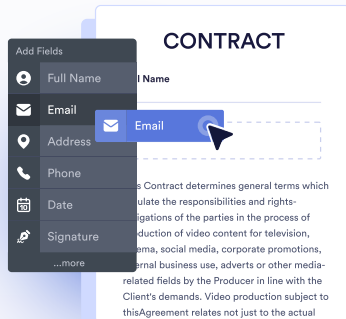

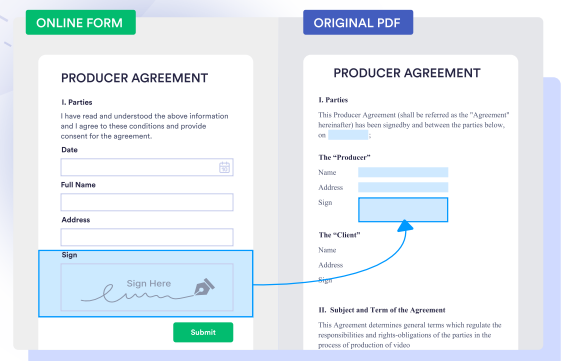
