THIS BROADCAST AGREEMENT ("Agreement"), is made on this _____ day of _____, _____, by and between the following:

1. PERIOD

The term of this Agreement shall commence on the first game for the season and shall continue until the same date the following year (the "Term"). This Agreement shall continue to renew for the same term after expiration until any of the parties herein express their intent to terminate this Agreement. Should any party wish to terminate this Agreement, the intending Party shall make the intention in writing.

2. SCOPE

This Agreement shall give title the Broadcaster as the official and exclusive broadcaster of the company for the game events and activities of the Company through the period and effectivity of this Agreement.

3. USE OF LOGO

The Company grants the Broadcaster the limited right to use the name, logo, trademark, tradename of the Company during the effectivity of this Agreement, including but not limited to promotion, broadcast, or literature.

4. PRODUCTION

Broadcaster shall be responsible for the broadcast and production of the events held by the Company and shall make the production, editorial, and technical matters of the Company's events.

5. FEE

Each game event by the Company shall amount to _____ (_____) per event, payable to Broadcaster.

6. WARRANTIES AND REPRESENTATION

The Company warrants and represents that it does not have any other relationship with other broadcasting agencies that are or may be in conflict with the Broadcaster or service provider. Company shall likewise prohibit itself from engaging with other broadcast agencies that may be in conflict with the interest of the Broadcaster herein.

7. ENTIRE AGREEMENT

This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof. No portion of this Agreement may be assigned to any third party without prior consent of the parties hereto.

8. MODIFICATION

No amendment or modification shall be made in this Agreement without the prior written consent of all the parties hereto.

9. COUNTERPARTS

The Parties may execute this agreement in multiple counterparts, each of which is an original but all of which shall constitute one and the same instrument.

9. SEPARABILITY CLAUSE

In the event that a competent court or authority finds and declares any of the provisions hereto as invalid, such invalidity shall affect only the said provision and the remaining provisions shall continue to be valid and enforceable.

9. WAIVER

The failure of any party to exercise their right under this Agreement shall not constitute a waiver. Only waivers made in writing and signed by the waiving party shall be constituted as a valid waiver by the waiving party.

10. GOVERNING LAW

This Agreement shall be construed in accordance with the laws of the State of _____ without regard to conflict of law principles.

11. DISPUTE RESOLUTION

In the event that there be any claims, breach, controversy, or disputes arising out of or relating to this Agreement, such shall be submitted to and settled by arbitration in accordance with the commercial arbitration rules of the American Arbitration Association. Decisions made pursuant to such dispute shall be binding and conclusive to the parties hereto.
