RE: Cease and Desist – Notice of Alleged Wrongdoing and Demand for Immediate Remedial Action

Dear Recipient,

This letter serves as a formal cautionary notice and a demand that you cease and desist from the actions described below. It is sent without prejudice to any of Sender's rights, claims, or remedies, all of which are expressly reserved.

If you do not immediately discontinue the conduct described above, Sender is prepared to pursue all appropriate legal remedies, including but not limited to filing a civil lawsuit seeking injunctive relief, seeking compensatory, punitive, or statutory damages, pursuing claims for breach of contract or breach of statutory duties and/or seeking an order for the delivery or destruction of infringing or unlawfully obtained materials.

We emphasize that the above list is not exhaustive, and we reserve the right to pursue any and all legal avenues deemed necessary.

Nothing contained in this letter shall be construed as a waiver of any rights, remedies, or claims available to Sender, all of which are expressly preserved. This letter is intended to put you on formal notice, and your continued misconduct may be deemed intentional, willful, and in bad faith.

You are required to issue a formal written response within a reasonable time frame, confirming full cessation of all identified activities, completion of all required removals or corrective steps and a commitment to prevent recurrence of similar conduct. Non-response will be deemed a refusal to comply and may result in the commencement of legal action.





