In the event that the compensation is not paid by the due date, the Helper reserves the right to suspend services until payment is received.

Term and Termination

This Contract has been signed for an indefinite period. The parties may mutually agree to terminate this Contract by providing written consent. Both parties must sign the termination notice for it to be valid.

If either party breaches any material term or condition of this Contract, or if the Client does not satisfied by the services provided, the non-breaching party may terminate this agreement with providing _____ days prior notice.

Upon termination of this Contract, both parties shall return any property, keys, or items belonging to the other party. Any outstanding obligations or payments shall be settled promptly. Termination does not release either party from any liabilities or obligations incurred before the effective date of termination.

Confidentiality

The Helper agrees and undertakes to keep all confidential information confidential and not disclose, reveal, or make it accessible to any third party without the prior written consent of the Client except legal requirements. Confidential information may include, but is not limited to, personal information, schedules, daily routines, preferences, and any other information of the Client that is not publicly available.

Equipment and Expenses

The Client is solely responsible for purchase and maintain necessary cleaning supplies, detergents, and other consumables required for completing chores. The Helper delivers the list of needs to the Client on a weekly basis.

Independent Contractors

The parties to this Contract are independent contractors. Nothing in this Contract shall be construed to create an employer-employee relationship, partnership, joint venture, or any other form of association between the parties.

Insurance

Helper is responsible for obtaining and maintaining their own insurance coverage, including but not limited to liability insurance, health insurance as deemed necessary.

Governing Law

This Contract shall be governed by and construed in accordance with the applicable laws of the State of _____ . All disputes arising out of or in accordance between this Contract shall tried to be resolved amicably first.
