The Church may rely upon this pledge for budgeting, planning, fundraising, financing, and project development purposes. However, this pledge is not intended to create undue hardship on the donor, and any requested modification to the payment schedule may be discussed with the Church in good faith.

Use of Funds

Unless otherwise agreed in writing by the Church, all funds contributed pursuant to this pledge shall be used for building fund purposes, including but not limited to property acquisition, construction, renovation, expansion, repairs, furnishings, equipment, architectural services, engineering services, permits, financing costs, and other expenses reasonably related to approved building projects.

Should project priorities change, the Church may allocate contributed funds to related building fund needs that are consistent with the overall purpose of the campaign.

Tax and Financial Acknowledgment

The Church agrees to maintain records of contributions received under this pledge and, where applicable, provide contribution acknowledgments for the donor's records.

The donor understands that tax treatment of charitable contributions depends upon individual circumstances and applicable laws and that neither this pledge nor the Church's acknowledgment constitutes tax advice.

Confidentiality of Donor Information

The Church shall make reasonable efforts to protect the confidentiality of the donor's personal information and shall use such information only for administrative, communication, fundraising, recordkeeping, and related ministry purposes, except where disclosure is required by law.

Amendment

Any modification of this pledge, including changes to the pledged amount or payment schedule, should be documented in writing and acknowledged by both the donor and an authorized representative of the Church.

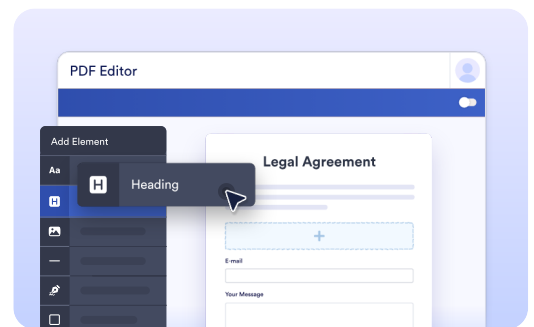

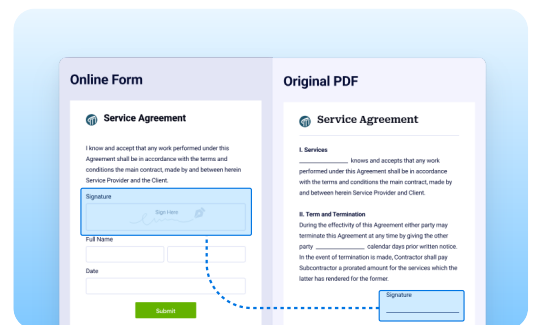
