This **Classroom Contract** ("**Contract**") is entered into on _____ ("**Effective Date**"),

1. Purpose

The purpose of this Contract is to establish clear expectations, responsibilities, and standards of conduct within the classroom environment. This Contract is intended to promote a respectful, safe, and productive learning experience for all participants.

2. Scope and Applicability

This Contract applies to all classroom activities, whether conducted in person, online, or in a hybrid format. It governs behavior, participation, academic integrity, and adherence to institutional policies throughout the duration of the course.

3. Term

This Contract shall remain in effect from the Effective Date until the conclusion of the _____, unless terminated earlier in accordance with the Termination clause.

4. Responsibilities of the Institution

The Institution agrees to:

- Deliver course materials, instruction, and assessments in a timely and professional manner
- Treat all students fairly and without discrimination

5. Responsibilities of the Student

The Student agrees to:

The Student acknowledges the importance of honesty in academic work and agrees to:

- Submit original work unless collaboration is expressly permitted
- Properly cite all sources and references
- Refrain from cheating, plagiarism, or any form of academic misconduct

Any violation of academic integrity may result in penalties, including but not limited to grade reduction, failure of the assignment, or further disciplinary measures.

8. Communication

The Student agrees to:

- Regularly check official communication channels, including _____

The Institution may update or amend this Contract as necessary. Any changes will be communicated to the Student in advance and will take effect on the specified date.

12. Governing Law

This Contract shall be governed by and interpreted in accordance with the general principles of applicable law in the jurisdiction where the Institution operates.

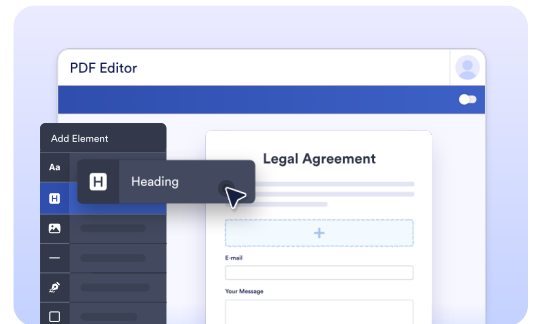

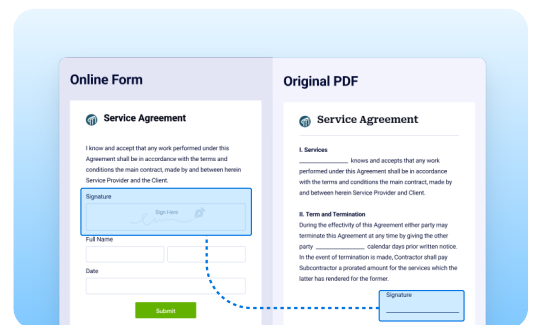

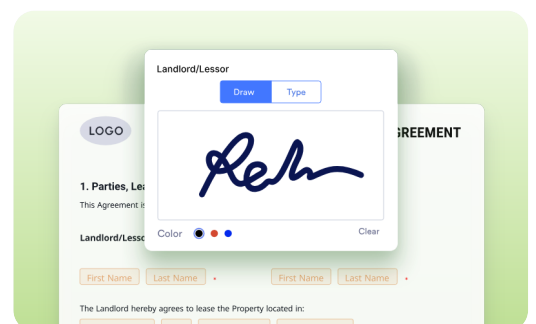
