This Dance Contract (hereinafter known as "Agreement"), executed on this _____ day of _____, _____, by and between:

WHEREAS, Company offers memberships for production performances;

WHEREAS, Dancer is a performer who desires to be a member of Company to avail the opportunities the latter offers;

WHEREAS, Parties Agree to enter this Agreement under the terms herein, and other regulations which may be published from time to time;

NOW THEREFORE, in consideration of the foregoing premises mises and covenants set forth herein, the Parties agree as follows:

REMUNERATION

Company agrees to pay Dancer the amount of _____ (_____) paid _____.

DUTIES AND RESPONSIBILITIES OF DANCER

During the Contract Period, Dancer agrees to participate in all shows and events by or in which the Company necessitates. It shall be the duty of Dancer to attend scheduled practices, training, and classes unless prior consent by the Dance Director was given otherwise. Detailed policies shall be provided by Company to Dancer in an addendum to this Agreement.

Dancer represents that he/she is in good condition in terms of physical health. All information that may affect Dancer's performance such as significant illnesses and injuries have been disclosed prior to entering into this Contract. Dancer shall subject himself/herself to annual medical check-ups provided by Company.

POLICIES

Company may, from time to time, amend or modify its rules and regulations for which Dancer is involved at its sole discretion and without need for consultation.

HEALTH GUIDELINES

Guidelines shall be provided by Company in accordance with Federal, State, and Local regulations. It shall be the responsibility of the Parties to ensure health safety compliance standards in the prevention of the spread of diseases such as, but not limited to, COVID-19.

MEDIA PUBLICATION

Company reserves the right to record, videotape, or photograph any of its activities involving Dancer for various purposes which would serve Company. By signing this Agreement, Dancer consents to such recording and taking of photographs and authorizes Company to the distribution of the materials via print, social, or any traditional forms of media that may include Dancer in its production content for publication.

NON COMPETE

Dancer agrees to not engage in any other company or organization that is in compete with Company during the effectivity of this Agreement.

TERM

This Agreement shall commence on the date of execution as above stated and shall terminate on the same month and day the following year, subject to the renewal of the parties herein.

RELATIONSHIP

Dancer is a member of Company under the terms and conditions set forth herein and is not an employee, has no authority of any kind to speak for or bind Company for any purpose or act as an agent of Company unless such authority is set forth in writing by Company.

NON-ASSIGNMENT

Dancer may not assign their rights and obligations to this Agreement

NO WAIVER

No waiver shall be considered as having been made whether express or implied in absence of a written consent signed by the waiving party.

COUNTERPARTS

This contract may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same contract.

SEPARABILITY CLAUSE

Should any of this contract be held invalid by any competent court, the same shall apply only to the provision involved, and the remaining provisions hereof shall remain valid and enforceable.

AGREEMENT MODIFICATION

No modification or alteration of this Contract shall be considered as having been made unless executed in writing and duly signed by the parties hereto.
