

Data Sharing Agreement

1. Parties

This **Data Sharing Agreement** (shall be referred as "**Agreement**") has been signed on _____, to arrange the principles of data sharing arising from the contractual relationship between the parties below;

The "Data Provider"

The "Data Recipient"

2. Purpose and Scope

The subject of this Agreement is to arrange the rights and obligations of the Data Provider and Data Recipient in the transfer of data, which will be specified below, within the scope of the relevant legislation.

Under this Agreement the term data means the information provided by the Data Provider to the Data Receiver within the scope of the contractual relationship between the parties, including but not limited to _____ (shall be referred as the "**Data**" as a whole).

3. Data Protection and Security

- The Parties know and accept the importance of protecting the privacy and security of the Data. They accept, declare and undertake to comply with all applicable data protection and privacy laws, regulations, and industry standards throughout the data sharing process.
- The Data Recipient shall take necessary actions to ensure the security of data and takes all kinds of technical and administrative measures in order to comply with the legal requirements and the adequate measures determined by the governmental authorities in order to ensure that the transferred data are processed in accordance with the applicable law.

- The Data Recipient shall promptly notify each other in writing of any actual or suspected unauthorized access, use, or disclosure of the shared data ("**Data Breach**"). In such a case, the Parties shall cooperate and take all necessary actions to minimize the effects of the Data Breach, comply with applicable legal requirements, and prevent any recurrence.
- The Data Recipient accepts that the Data Provider has authority to audit and authority to give orders to the Data Recipient about whether the Data Recipient has fulfilled its commitment and obligations, and provides required convenience to the Data Provider in this situation.
- If the contractual relationship between the parties expires, depending upon the preference of the Data Provider, the Data Recipient accepts that they will send the Data and its back-up to the Data Provider, or destruct/destroy/annihilate Data entirely, and stop data processing.
- The Data Recipient is obliged to keep the Data confidential and secure indefinitely. The Data Recipient cannot share the Data with any third party or institution in the country or abroad without the prior written consent of the Data Provider, except for the allowed situations in this Agreement.
- The Data Recipient may disclose the Data with third parties or institutions, only in accordance with its legal obligations, provided that the Data Provider is informed in writing on this matter. In such a case the Data Recipient is obliged to inform and supervise the third parties and institutions regarding all requirements and measures specified in the relevant legislation and in this Agreement.

4. Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of _____ . Any dispute, or claim arising out of or in connection with this Agreement, including any question regarding its existence, validity, or termination, shall be resolved through good faith negotiations between the parties.

In cases where there is no provision in this Agreement, the provisions of the main contract between the parties shall be applicable.

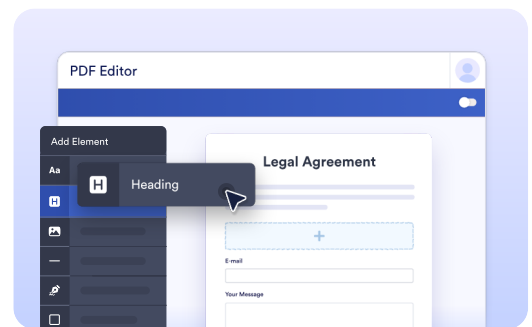

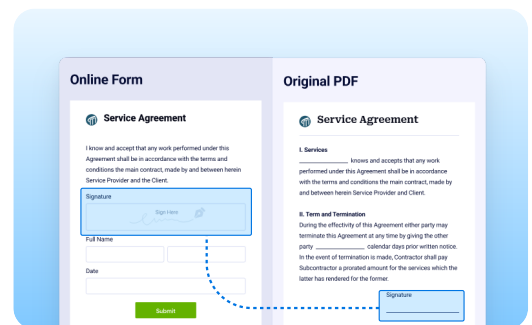

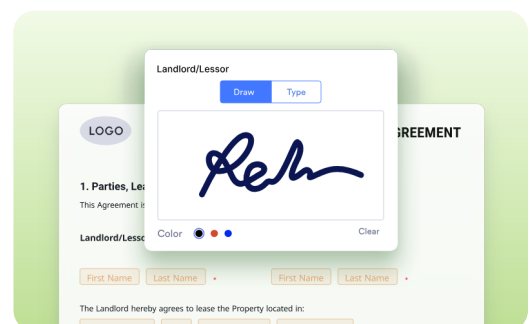
