Term and Conditions

- The Dog Walker agrees and undertakes to provide dog walking services to Pet Owner during the period of this Contract, everyday of the week excluding sundays. The service will be provided once a day, between _____ - _____ am.
- Dog walking services shall take place at neighborhood, especially at _____.
- The Dog Walker shall be paid _____ as monthly service fee and this amount shall be paid every _____ of each month.
- The Dog Walker shall engage in playtime and light exercise with the pet during the walks, as appropriate and in accordance with the pet's physical condition and preferences.

- All the necessary equipment including a suitable leash, collar or harness, and any other equipment for the pet's safety and control during walks shall be provided by the Pet Owner. The Dog Walker will ensure that all equipment is properly fitted and in good condition.
- The Dog Walker is responsible for the safety and health of the pet during the walks. In the event of a pet emergency or illness during a walk, the Dog Walker shall make reasonable efforts to contact the Pet Owner. If immediate veterinary attention is required, the Dog Walker will seek medical care for the pet at the Pet Owner's expense.
- Any additional services must be agreed upon in writing by both parties and may be subject to additional fees.
- If the Dog Walker is unable to provide service due to illness or any reason, he/she must notify the Pet Owner at least one day in advance and show someone who can provide the service, if possible.
- Any of the parties may terminate this Contract with a 7 days notice. If the Pet Owner terminates the Contract, the fee of all the service provided as of the termination date will be paid to the Dog Walker on the same day.
- This Contract shall be governed and construed in accordance with the applicable federal laws and the laws of the State of _____.

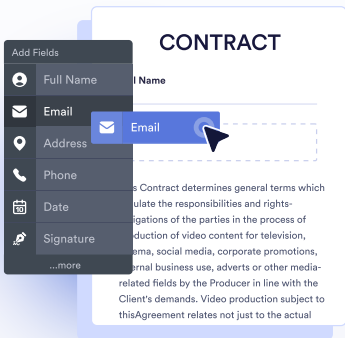

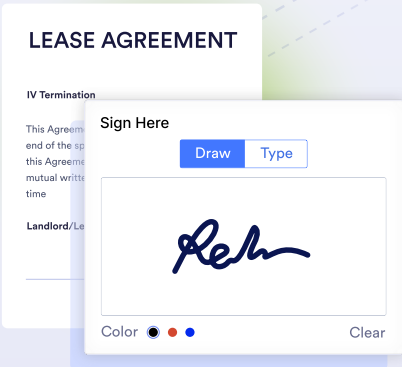
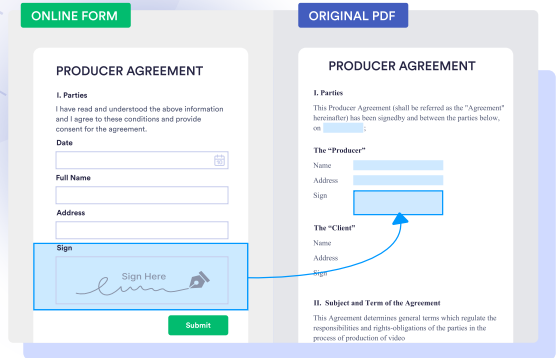
