

Dumpster Rental Contract

This **Dumpster Rental Contract** ("**Contract**" hereinafter) has been signed by and between the parties below;

WHEREAS the Company is a business that provides dumpsters for temporary use to individuals, businesses, construction sites, events, or any situation requiring waste disposal,

WHEREAS the Client is a _____ which is seeking professional waste disposal services,

NOW THEREFORE, in consideration of the premises and the mutual covenants, the parties agrees as follows;

I. Dumpster Specifications

Within the scope of this Contract, the Company agrees to rent dumpster to the Client which has the following features and qualities;

The Client shall ensure that the designated placement area for the dumpster is accessible and suitable for the delivery truck to drop off and pick up the dumpster without disallowance.

The dumpster shall be used solely for the disposal of _____. Prohibited materials such as hazardous waste, chemicals, asbestos, batteries, tires, and other restricted items shall not be disposed of in the dumpster. The Client shall be solely responsible for any damages that may occur if the mentioned substances are thrown into the dumpster.

II. Term of the Contract

The term of this Contract is _____, starting from _____ to _____ . The installation is carried out and completed on the date the Contract begins. Unless otherwise agreed by the parties in writing, the dumpster shall be taken back by the Company on the day the Contract ends.

Any extension to the rental period beyond the agreed-upon end date must be requested by the Client in writing at least _____ before the abovementioned end date. The Company reserves the right to approve or deny the extension based on availability and other considerations.

III. Cost and Payment Terms

As rental fee, the Client agrees to pay _____ per _____, and this amount is inclusive of delivery, pickup, maintenance and usage during the term of the Contract. A non-refundable deposit of _____% of the total rental fee is required to secure the dumpster rental. The deposit shall be paid upon signing this Contract and shall be returned at the end of the rental period. All payments under this Contract shall be made in _____.

In the event of late payment, the renter shall be subject to late fees of _____ for each day the payment remains overdue past the specified due date.

Any additional fees incurred due to overage charges (exceeding weight limits), damages to the dumpster beyond normal wear and tear, or extra services requested by the Client shall be billed separately and payable upon receipt of the invoice.

IV. Business Licenses

The Company represents and warrants that all employees and personnel associated with the services and the Company shall comply with federal or state withholding laws and regulations requiring any required licences, permits, and certificates necessary to perform the disposal services under this Contract. Upon request by the Client, the Company agrees to provide proof of compliance with all applicable licensing, permitting, and certification waste disposal requirements.

V. Indemnification

The Company agrees and undertakes to bear all responsibility for the actions related to themselves and their employees or personnel under this Contract. The Company agrees to indemnify, defend, and hold harmless the Client from and against any claims, liabilities, damages, losses, costs, or expenses arising out of or related to the Company's performance of the waste disposal services under this Contract, except to the extent caused by the Client's negligence or willful misconduct.

VI. Miscellaneous Provisions

Governing Law. This Contract shall be governed and construed in accordance to the laws of the State of _____.

Severability. In the event that any of the provisions of this Agreement is held to be invalid or unenforceable, this shall remain valid and in effect and all of its remaining provisions except the one held invalid or unenforceable.

Non-Waiver. The failure of any Party to insist upon the strict compliance with and performance of any of the terms, conditions, and covenants herein shall not be deemed as a waiver of the said party from any breach by the other from this Agreement. Only express waivers by which such is to be made in writing and signed by the waiving party shall be considered as such waiver as having been made.

Relativity. This Agreement inures to the benefit of, and is binding upon the successors and assigns of the Parties hereto.

Counterparts. This Agreement may be executed in two or more electronic counterparts each of which shall be deemed an original and all of which together shall constitute one and the same agreement.
