4. Cancellation and Termination

The Client may cancel the performance or services by providing written notice to the Entertainer at least _____ days before the scheduled performance date. In the event of cancellation by the Client, the Entertainer shall be entitled to retain any deposit or advance payment made by the Client, unless otherwise agreed upon in writing.

The Entertainer may cancel the performance or services provided for in this Contract only due to circumstances beyond their control, including but not limited to illness, accident, or force majeure. In the event of cancellation by the Entertainer, the Entertainer agrees to refund any amounts paid by the Client in full within _____ of the cancellation date.

Either party may terminate this Contract at any time with written mutual agreement.

5. Force Majeure

Within the scope of this Contract, force majeure events may include, but are not limited to, acts of nature, natural disasters, strikes, riots, war, terrorism, governmental actions, or any other events deemed beyond the control of the parties.

As also referred in Section 4 of this Contract, Neither party shall be liable for any failure or delay in performing their obligations under this Contract when such failure or delay is directly caused by force majeure events beyond the reasonable control of the party affected.

6. Indemnification

The Client agrees to indemnify, defend, and hold harmless the Entertainer, their agents and representatives from and against any and all claims, liabilities, damages, losses, or expenses, including reasonable attorney fees, arising from any breach of this Contract by the Client or any injury, loss, or damage to property caused by the Client or the Client's guests, invitees, or attendees during the event or performance.

7. Governing Law and Jurisdiction

This Contract shall be governed by and construed in accordance with the laws of the State of _____.

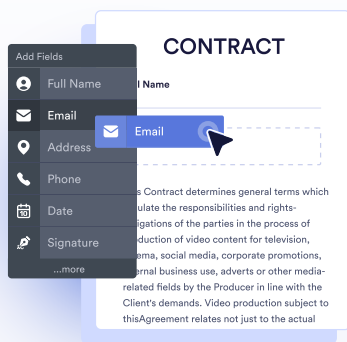

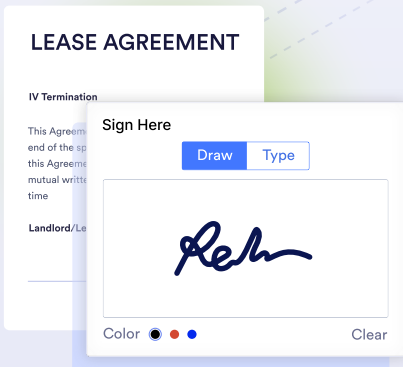
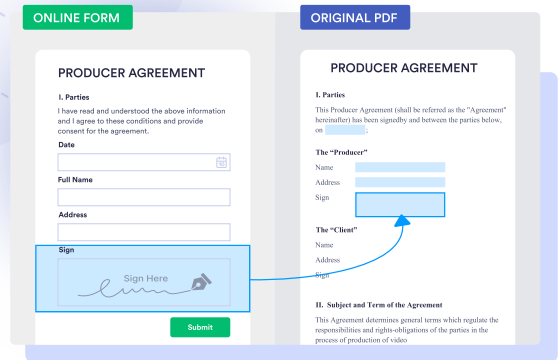
