

Event Decorator Contract

1. Parties

This Event Decorator Contract (shall be referred as "**Contract**" hereinafter), executed on _____ ("**Execution Date**") by and between the Parties below.

2. Subject of the Contract

The subject of this Contract is the determination of the rights and obligations of the parties regarding the decoration of the venue by the Decorator for the event that is defined below, in line with the Client's requests.

3. Price and Payment Plan

The total price of the all services to be provided by the Decorator under this Contract is _____.

As down payment, 70% of total amount shall be paid within 3 (three) days following the execution of the Contract. The balance amount shall be paid at the date of the Event, by the end of the working hour at the latest. All payments shall be made by bank transfer.

If the down payment is not paid on time, the Decorator may suspend service provision. In this case, a delay penalty of _____ is applied per day of delay. If there is such a delay that the decoration cannot be completed until the date of Event, the Decorator may terminate the Contract without any compensation.

4. Right and Obligations of the Decorator

- The Decorator reserves the right to suspend its services anytime when it firmly believes that there is risk or threat to the safety and security of its staff. However, in such a case, the Decorator is obliged to immediately inform the Client and share the details of the security vulnerability. The Decorator shall continue to work with its staff as soon as the vulnerability is fixed.
- The Decorator may display, use, and publish video and photographs from events for promotion in Decorator's social media accounts and on its website for purpose of promotion of its services. All videos or images shall be subject to the approval of the client as to their personal identity. However, Decorator shall possess full ownership over the photo and video materials.
- The Decorator is obliged to have at least two contact persons in the event venue on the day of the Event. Reasonable requests of the Client shall be met through these persons.

- The Decorator presents the samples to the Client in accordance with the Client's demands within a reasonable time after the signing of the Contract. The Client notifies the decorator of their choice in writing. If the selected products cannot be supplied, the Decorator is obliged to provide the equivalent of the product by obtaining the Client's approval, without reflecting the price difference.
- The Decorator cannot demand a price difference for any reason such as price increase, supply difficulty, etc. If the Client has a new request other than the ones mentioned above or if a product is requested from a different category, the Client shall pay the price difference.
- Decorator assures that all materials and decor items are in excellent condition and shall be decorated by the Decorator's professional staff. Decorator shall not be held responsible for if any of the expectations of the Client is not met due to prohibitions or obstacles on the venue that prevents Decorator from implementing such design.

5. Right and Obligations of the Client

- The Client knows and accepts that all of the materials used for decoration are in the possession of the Decorator. Since all of the materials will be taken back by the Decorator, the Client is responsible for the careful use of all materials during the event. Any damage resulting from the event of Client shall be borne by Client including the cost of repair or replacement.
- If this Contract is signed for an outdoor event, the Client shall be responsible for providing an alternate location. Client agrees to release Decorator from all liability.
- Client agrees in ensuring that the arranged venue shall be available to Decorator free from any items that may inhibit delivery and setup of decorations. The Client shall ensure the availability of the venue at least four (4) hours before the event for venue decoration.
- The Client shall promptly notify the Decorator in writing if the event is canceled for any reason. The Client knows and accepts that the down payment shall not be refunded, if the event cancellation is notified after _____.

- The Client may refrain from making the final payment if the requests are not met in the written request list, or request from the Decorator to make a discount for the missing items.

6. Independent Contractors

The relationship between the Decorator and the Client is that of independent contractors. Nothing contained in this Agreement shall be construed as creating any agency, partnership, joint venture or other form of joint enterprise, employment or fiduciary relationship between the parties, and neither party shall have authority to contract for or bind the other party in any manner whatsoever.

7. Force Majeure

Notwithstanding anything to the contrary contained herein, the parties shall not be liable for any delays or failures in performance resulting from acts beyond its reasonable control including, without limitation, acts of God, terrorist acts, shortage of supply, breakdowns or malfunctions, interruptions or malfunction of computer facilities, or loss of data due to power failures or mechanical difficulties with information storage or retrieval systems, labor difficulties, war, or civil unrest.

In such a case, the down payment paid by the Client is returned, with the exception of the expenses incurred by the Decorator during the preparation stage.

8. Miscellaneous Provisions

- **Seperabilty** - Should there be any declaration of invalidity or enforceability by any court or competent authority in any of the provisions hereto, the same shall apply only to the said provision, and the remaining provisions hereof shall remain valid and enforceable.
- **Modifications** - No modification or alteration of this Contract shall be considered as executed and enforceable unless otherwise made in writing and signed by the parties hereto.

- **Notifications** - Any notice, demand, approval, request, or other communication required or permitted under this Contract must be in writing and either delivered personally, sent by certified or registered mail, or prepaid postage to the addresses indicated in this Contract.
- **Competent Courts** - Any dispute that requires legal resolution or any action arising from or brought under this Contract shall be filed with the proper courts of _____, to the exclusion of all other venues.
- **Governing Law** - This Contract shall be governed by and construed in accordance with the laws of the State of _____.

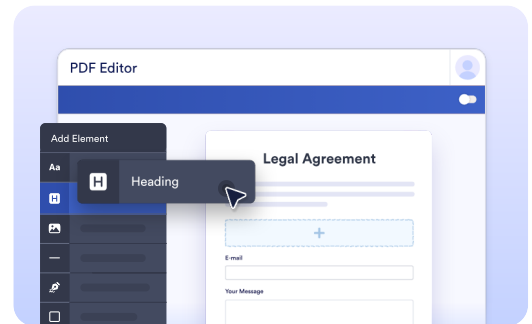

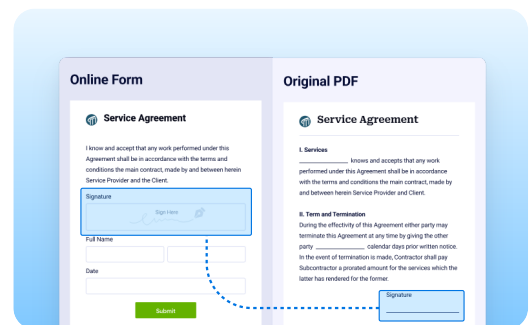
