



## 2. Compensation

The Artist shall pay a total exhibition fee of \_\_\_\_\_ per day. In addition, the artist also agrees to pay a \_\_\_\_\_ % commission on each work they sell.

A non-refundable deposit of \$ \_\_\_\_\_ is due upon signing of this Contract. The remaining balance of \$ \_\_\_\_\_ is due no later than one day before the start date of the Exhibition, on \_\_\_\_\_.

If the Artist fails to pay any payments on due date, the Gallery reserves the right to impose a late fee of \$ \_\_\_\_\_. Additionally, the Organizer may, at its discretion, release the reserved exhibition space to another exhibitor.

## 3. Intellectual Property Rights

All intellectual property rights on the artworks belong to the Artist, within the limits set by the applicable intellectual property law.

The Gallery is not prohibited to use any copies or reduces size copies on any materials or posters of exhibition without written consent of the Artist.

## 4. Publicity

The Gallery is solely responsible for the marketing activities regarding the exhibition, and shall be responsible for design, layout, content, printing and distribution of the marketing material. The Artist shall provide the Gallery its biography and list and information of all artworks to be exhibited. The Artist shall also provide the Gallery at least two black and white photographs of a quality suitable for reproduction showing pieces of work to be exhibited.

## 5. Other Issues

- The Gallery shall be solely responsible for security measures during the exhibition. This includes security personnel, rules of the event, security policies, protection from dangers like theft, loss, vandalism, fire, smoke, and water damage.

- If the exhibition is canceled for any reason, the Gallery is not obliged to pay any compensation to the Artist unless there is a fundamental fault of the Gallery.
- Any changes or amendments to this Contract require written consent from both parties involved.
- This Contract shall be governed by and construed in accordance with the applicable federal laws and the laws of the State of \_\_\_\_\_.
