## Terms and Conditions

- This **Flea Market Vendor Contract** (the "**Contract**" hereinafter) has been signed by and between the Vendor and the Client indicated above. The Vendor is a professional supplier of flea market products, and the Client is seller of a flea market.
- The Vendor agrees to provide the following products for sale by the Client at the flea market;
- The Client shall pay the Vendor in accordance with the rate card below. All payments under this Contract shall be made via \_\_\_\_\_. During the delivery of the products, the invoice will be presented to the Client and payment will be made within \_\_\_\_\_ days at the latest. Late payments shall be subject to \_\_\_\_\_ % interest rate.
