FOOD TRUCK CONDITION. The Lessor is leasing the food truck AS IS and WHERE IS. No warranties will be given to the Lessee which is why ample time is provided to the Lessee to inspect the food truck or even hire an inspector to check the food truck before buying it.

INDEMNIFICATION. The Lessor will not be liable for any expense, damage, or loss to any person or Lessee's property. The Lessor will not be liable for theft. The Lessor will not be liable for any injury, illness, or damage to other persons.

CONFIDENTIALITY. The content of this Food Truck Lease Agreement is considered strictly confidential. If a third party needs to view it, written approval or authorization should be provided by both parties.

WAIVER. The Parties involved in this Food Truck Lease Agreement have the ability to waive any provision, rights, or obligations, under this Food Truck Lease Agreement. If there should be any provision, rights, or obligations that need to be waivered, a written agreement and approval will be required.

AMENDMENT. No modification or change of this Food Truck Lease Agreement shall be considered valid unless made in writing and agreed upon by the involved parties.




