- The Franchisee will be in control of managing, operating, and improving the franchise business.

## RIGHTS

The rights, copyrights, and trademarks of this franchise belong to the Franchisor. The Franchisee will have limited rights to use the rights for the purpose of marketing, promotion, and advertisements.

## RENEWAL

If the party decided to have the franchise license renewed, then a new agreement will be created after the term of the previous agreement.

## TERMINATION

This Franchise Agreement can be terminated if the parties involved violated the terms, conditions, and agreement in this document.

Non-payments or violations of the payment agreement which is a separate agreement from this one can result in termination of this Agreement.

## CONFIDENTIALITY
