

Freelance Animation Contract

This **Freelance Animation Contract** ("**Agreement**") is entered into as of _____ ("**Effective Date**"), by and between the following parties:

Animator

Client

Client and Animator may be referred to individually as a "**Party**" and collectively as the "**Parties.**"

1. Purpose

The purpose of this Agreement is to define the terms under which the Animator will provide animation services to the Client, including the scope of work, delivery expectations, compensation, and ownership rights.

2. Scope of Services

The Animator agrees to create animation content as requested by the Client. The specific project details are set out below:

The Animator shall perform the services in a professional manner consistent with industry standards.

3. Timeline and Delivery

The Animator shall deliver the work according to the agreed timeline. Any delays must be communicated promptly to the Client.

The Client agrees to provide timely feedback, approvals, and any required materials necessary for the Animator to complete the work.

4. Revisions

The Animator shall provide _____ rounds of revisions included within the agreed fee. Additional revisions requested by the Client may be subject to additional charges, which must be agreed upon in writing before proceeding.

5. Compensation

In consideration for the services provided, the Client agrees to pay the Animator as follows:

Late payments may result in suspension of work until payment is received.

6. Independent Contractor Status

The Animator is engaged as an independent contractor. Nothing in this Agreement shall be interpreted as creating an employer-employee relationship, partnership, or joint venture.

The Animator is solely responsible for taxes, insurance, and any legal obligations related to their business operations.

7. Intellectual Property Rights

Upon full payment of all fees due under this Agreement, the Animator assigns to the Client all rights, title, and interest in the final deliverables.

Until full payment is received, all rights remain with the Animator.

The Animator retains the right to display the completed work in portfolios, showreels, and promotional materials, unless otherwise agreed in writing.

8. Client Materials

The Client is responsible for ensuring that any materials provided to the Animator (including scripts, logos, or assets) do not infringe on third-party rights.

The Client grants the Animator a limited license to use such materials solely for the purpose of completing the project.

9. Confidentiality

Each Party agrees to keep confidential any non-public, proprietary, or sensitive information received from the other Party during the course of this Agreement.

This obligation continues after the completion or termination of this Agreement.

10. Termination

Either Party may terminate this Agreement by providing written notice to the other Party.

If terminated:

- The Client shall pay the Animator for all work completed up to the termination date.
- Any completed and paid-for deliverables shall be delivered to the Client.
- Any unpaid work remains the property of the Animator.

Termination does not affect rights or obligations that have accrued prior to termination.

11. Limitation of Liability

The Animator shall not be liable for any indirect, incidental, or consequential damages arising out of or related to this Agreement or the use of the deliverables.

The Animator's total liability shall not exceed the total amount paid under this Agreement.

12. Governing Law

This Agreement shall be governed by and interpreted in accordance with the laws of _____, without regard to conflict of law principles.

13. Entire Agreement

This Agreement constitutes the entire understanding between the Parties regarding its subject matter and supersedes all prior discussions or agreements.

Any amendments must be made in writing and signed by both Parties.

14. Notices

All notices under this Agreement shall be in writing and delivered to the addresses listed above or to any updated address provided in writing by either Party.

15. Signatures
