



Gift Agreement

This **Gift Agreement** ("**Agreement**") is entered into on _____ by and between the following parties:

Donor

Recipient

1. Purpose

The purpose of this Agreement is to document the voluntary and unconditional transfer of certain property from the Donor to the Recipient as a gift, without expectation of payment, compensation, or consideration.

2. Description of Gift

The Donor agrees to transfer and deliver to the Recipient the following property ("**Gift**"):

3. Nature of the Gift

The Donor confirms that:

- The Gift is made voluntarily and without any coercion or undue influence.
- The Gift is not given in exchange for any services, promises, or other consideration.
- The Donor does not expect any future benefit, financial or otherwise, from the Recipient in connection with the Gift.

4. Ownership and Title

The Donor represents that:

- The Donor is the lawful owner of the Gift and has full authority to transfer it.
- The Gift is free from any liens, claims, encumbrances, or third-party rights.

Upon delivery, full ownership and title to the Gift shall pass to the Recipient.

5. Delivery of the Gift

The Gift shall be delivered to the Recipient as follows:

6. No Revocation

Once the Gift has been delivered and accepted by the Recipient, the transfer is final and irrevocable, except where required by applicable law.

7. Recipient Acceptance

The Recipient acknowledges and accepts the Gift as described in this Agreement and understands that it is provided without any warranties, unless expressly stated otherwise in this Agreement.

8. No Warranties

The Gift is provided "as is," and the Donor makes no representations or warranties, express or implied, regarding the condition, quality, or fitness for any particular purpose of the Gift, unless otherwise specified in writing.

9. Tax Responsibility

Each party acknowledges that the transfer of the Gift may have tax implications. The Donor and Recipient agree that they are individually responsible for determining and fulfilling any tax obligations arising from this transaction.

10. Governing Law

This Agreement shall be governed by and interpreted in accordance with the laws of _____, without regard to conflict of law principles.

11. Entire Agreement

This Agreement constitutes the entire understanding between the parties regarding the Gift and supersedes all prior discussions or agreements, whether written or oral.

12. Amendments

This Agreement may only be amended or modified by a written document signed by both the Donor and the Recipient.

13. Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.

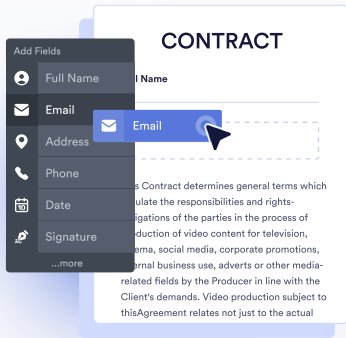

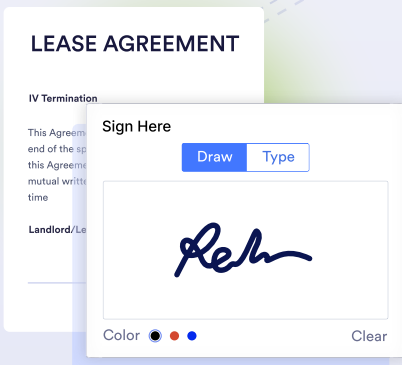
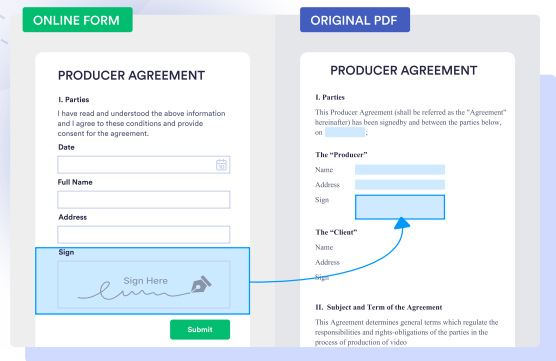
