3. School's Responsibilities

It shall be School's responsibility to:

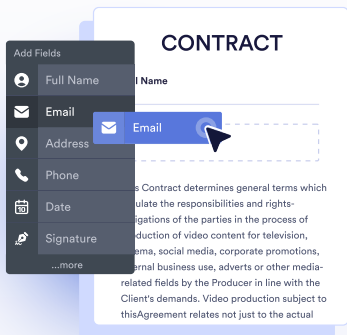

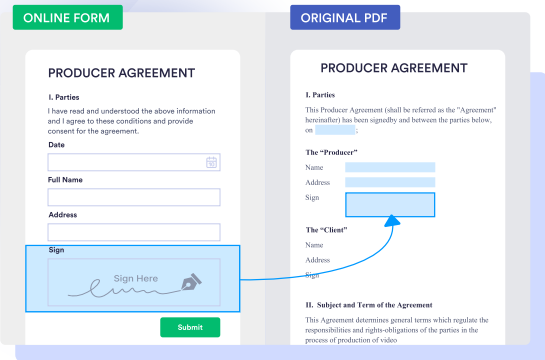

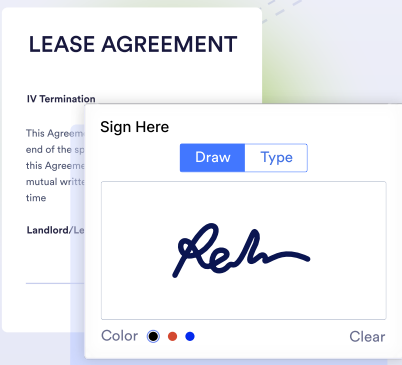
