This **Non-Solicitation Agreement** (the “**Agreement**”) has been signed by and between the following parties:

WHEREAS, the Independent Contractor has been engaged by the Client to provide certain services as an independent contractor, with an Independent Contractor Agreement dated _____,

WHEREAS, during the course of the engagement, the Independent Contractor will have access to the Company's clients, customers, and employees,

WHEREAS, the Company desires to protect its relationships with its clients, customers, and employees,

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the parties hereby agree as follows:

Terms & Conditions

Non Solicitation for Client and Customers

For a period of _____ months after expiration or termination of the Independent Contractor Agreement, the Independent Contractor agrees that they will not, directly or indirectly, for themselves or on behalf of any other third parties, solicit or attempt to solicit, or take away any client or customer of the Client with whom the Independent Contractor had material contact during the course of their engagement with the Client.

Non Solicitation for Employees

For a period of _____ months after expiration or termination of the Independent Contractor Agreement, the Independent Contractor agrees that they will not, directly or indirectly, for themselves or on behalf of any other third party, solicit, induce, or attempt to solicit or induce any employee, consultant, or independent contractor of the Client to terminate their relationship with the Client or to engage in any activities that would be competitive with the Client.

Geographic Scope

The non-solicitation obligation of the Independent Contractor is only valid and enforceable in the following area; _____.

Enforcement

The Independent Contractor acknowledges that a breach of this Agreement would cause irreparable harm to the Client for which monetary damages would not be an adequate remedy. Therefore, the Client shall be entitled to seek injunctive relief, in addition to any other remedies available at law or in equity, to enforce the terms of this Agreement.

Entire Agreement

This Agreement constitutes the entire agreement between the Parties hereto with regard to the non-solicitation obligation of the Independent Contractor. This supersedes any communication made orally or any previous written agreements between the parties. Any communications made prior to this Agreement is hereby declared void and unenforceable.

Clauses of Independent Contractor Agreement

All provisions of the Independent Contractor Agreement concluded between the parties are valid and shall be applied to the extent they comply with this Agreement.

Governing Law




