1. Parties

This **Jet Ski Bill of Sale** (shall be referred as the "**Agreement**" hereinafter) has been signed by and between the parties below;

2. Jet Ski to Be Sold

The Seller hereby agrees to sell and transfer ownership of the following Jet Ski to the Buyer;

The Seller warrants that he/she is the legal owner of the Jet Ski and has the right to sell it. The Seller agrees to provide the Buyer a valid title and registration for the Jet Ski, free and clear of any liens or hypothecs.

3. Sales Price and Payment

The sales price for the Jet Ski is _____. The full sales price shall be paid at the time of delivery of the Jet Ski. Ownership of the goods passes to the Buyer when the total sales price is paid and the Jet Ski is delivered. Payment shall be made by _____.

If the Buyer fails to pay the full sales price at the time of delivery, the Seller may terminate this Agreement and demand reasonable fees and costs from the Buyer.

4. Right of Inspection

The Buyer has the right to inspect the Jet Ski prior to the payment and delivery. The Seller agrees to provide the Buyer with reasonable access to the Jet Ski for the purposes of inspection.

Upon inspection, if the Buyer detects a defect that has not been told by the Seller, or if the Jet Ski is found to be in an unsafe or un-roadworthy condition, the Buyer may terminate this Agreement and demand a refund of paid amount, if any.

The Seller warrants that to the best of their knowledge, the Jet Ski is in good working condition and conforms to the description provided. However, the Buyer acknowledges that the Seller makes no warranties, express or implied, as to the condition or fitness of the Jet Ski for any particular purpose.

5. Delivery

The Seller agrees to deliver the Jet Ski to the Buyer at

_____ on _____. The Seller will deliver the Jet Ski to the Buyer in the same condition as it was in at the time of inspection. If the Seller fails to deliver the Jet Ski on the agreed upon delivery date, the Buyer may terminate this Agreement.

The risk of loss or damage to the Jet Ski shall pass to the Buyer upon delivery. The Buyer is responsible for all costs and expenses associated with the delivery of the Jet Ski, including but not limited to transportation costs and any applicable taxes, fees or charges.

6. Other Considerations

- **Entire Agreement** - This Agreement represents the entire understanding between the parties and supersedes all prior negotiations, understandings and agreements between them.
- **Amendments** - This Agreement may not be amended or modified except in writing and signed by both parties.
- **Notices** - Any notice required to be given under this Agreement shall be in writing and shall be deemed to have been given upon personal delivery, mailing by above mentioned email, or postage prepaid to the addresses provided herein.
- **Governing Law** - This agreement shall be governed by and construed in accordance with the laws of the State of _____.
