

# Junk Removal Contract

This **Junk Removal Contract** ("**Agreement**") is entered into as of \_\_\_\_\_ ("**Effective Date**"), by and between the parties below:

The Service Provider and the Client may be referred to individually as a "**Party**" and collectively as the "**Parties**".

## 1. Purpose

The purpose of this Agreement is to set out the terms under which the Service Provider will provide junk removal and disposal services to the Client.

## 2. Scope of Services

The Service Provider agrees to collect, remove, and dispose of unwanted items from the location specified by the Client.

The services include, but are not limited to:

- Removal of general household or commercial waste
- Loading and hauling of designated items
- Transportation to appropriate disposal or recycling facilities

The specific details of the service are as follows:

The Service Provider reserves the right to refuse removal of hazardous, illegal, or prohibited materials.

### 3. Client Responsibilities

The Client shall:

- Ensure that all items for removal are clearly identified and accessible
- Provide safe and lawful access to the service location
- Disclose any items that may require special handling

The Client is responsible for obtaining any necessary permissions or approvals required for the removal of items.

### 4. Fees and Payment

The Client agrees to pay the Service Provider for the services in accordance with the following:

### 5. Scheduling and Access

The Client agrees to provide access to the premises at the scheduled time. If the Service Provider is unable to perform the services due to lack of access or Client delay, a rescheduling fee may be applied.

### 6. Disposal and Compliance

The Service Provider shall dispose of all collected materials in accordance with applicable environmental and waste management standards.

The Service Provider may, at its discretion, recycle or donate items where appropriate.

## 7. Risk and Liability

The Service Provider shall take reasonable care in performing the services. However, the Client acknowledges that minor damage may occur due to the nature of removal activities.

The Service Provider shall not be responsible for:

- Pre-existing damage at the service location
- Damage resulting from unsafe conditions or undisclosed hazards
- Items removed in accordance with the Client's instructions

## 8. Cancellation and Rescheduling

The Client may cancel or reschedule the service by providing at least \_\_\_\_\_ notice.

The Service Provider acts as an independent contractor and not as an employee, agent, or partner of the Client.

## 11. Governing Law
