# Terms and Conditions

## 1. Parties

This **Landscaping Proposal** is specially prepared for \_\_\_\_\_ (the "**Client**" hereinafter) by \_\_\_\_\_ (the "**Company**" hereinafter).

If the Proposal is approved, the parties agree on the execution of the planned works (the "**Project**" hereinafter) and it will be accepted as an agreement (the "**Agreement**" hereinafter) between the parties and terms and conditions set out below will be binding between the Client and the Company.

## 2. Term of the Project

This Agreement becomes effective upon the date of the last signature below ("**Effective Date**") and shall remain in effect until the Project is completed.

The term of the Project is \_\_\_\_\_. The Agreement automatically terminates at the end of this period if the work to be done is completed.

If the works to be done are not completed at the end of this period, the Company requests additional time from the Client by stating the reasons of delay. The termination of the Agreement due to delay is regulated in Article 5 of this Agreement.

## 3. Price and Payment Schedule

The total price to be paid under this Agreement is \_\_\_\_\_, \_\_\_\_\_ TL for the price of goods and \_\_\_\_\_ for the service charge. This amount is turnkey lump sum price.

The Company cannot demand a price increase for reasons such as an increase in worker wages, labor expenses or product prices or an increase in costs. If a job change is requested by the Client, the price may change. Price change is subject to the approval of both parties.

#### 4. Worker Wages and Other Labour Expenses

The workers who will work within the scope of the Project are the employees of the Company in principle. All costs and wages of workers, any other labor expenses are paid by the Company.

The Company accepts, declares and undertakes that it will work the workers in accordance with the applicable laws and regulations, that it will not employ them below the minimum wage required by the legislation and that it will take the necessary measures regarding occupational health and safety.

#### 5. Termination

The Agreement automatically expires on the completion of the Project.

If it is clearly understood that the Project will not be completed on the planned date, the Client may request an explanation from the Company with a warning letter.

If the Company indicates that the project will not be completed by the end of the period, the Client may terminate the contract immediately by giving written notice. In this case, the expenses incurred by the Company are deducted and the balance is returned to the Client.

If the Client does not make the first payment in 5 days as specified in Article 3 of this Agreement, the Agreement is deemed to have been withdrawn. If the first and second installments are not paid on time, the Company may terminate the Agreement by giving 7 days' notice. If payment is made within the notification period, the Agreement continues with the same terms and conditions.

In both cases, if the Company does not terminate the Agreement, for all late payments, a daily interest rate of \_\_\_\_\_ shall apply.

#### 6. Miscellaneous

- **Separability** - In case any provision in this Agreement shall be invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions shall not in any way be affected or impaired thereby.
- **Notifications** - All notifications under this Agreement shall be made in writing and made to the address and/or emails indicated in the first page of this Proposal.

- **Modifications** - This proposal can only be changed or modified by the Company. A new proposal will be made if the Client wishes to change the content of the document. After the approval of the Client, the terms and conditions of the Agreement shall only be modified or amended by the written mutual consent.
- **Assignment** - Neither this Agreement nor any of the rights, interests or obligations hereunder shall be assigned by any of the Parties without the prior written consent of the other Party.
- **Governing Law and Dispute Resolution** - All kinds of disputes arising from this Agreement shall be tried to be resolved primarily through peaceful resolution methods such as conciliation and mediation. The provisions of the Proposal and this Agreement shall be construed and interpreted in accordance with the laws of the State of \_\_\_\_\_.

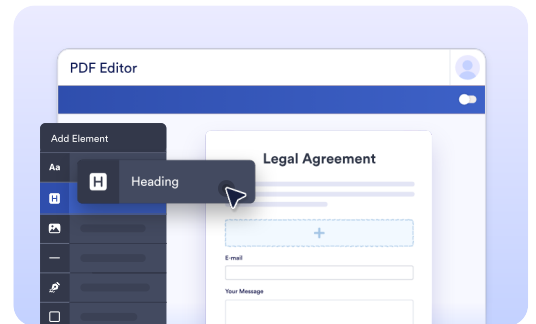

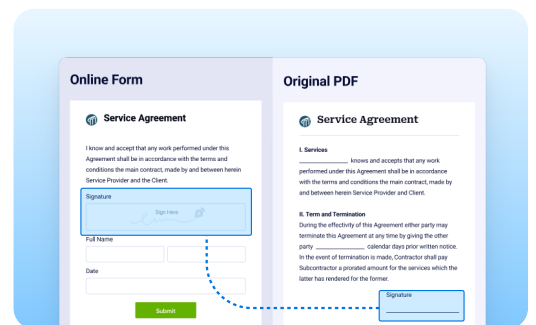

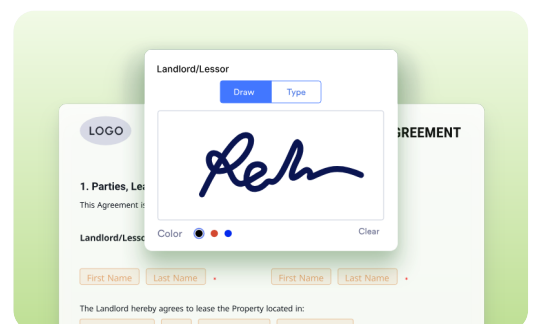
