This Make-up Artist Contract (the "Agreement"), executed on _____, is entered into by and between:

WHEREAS, Client desires to hire Artist for performing make-up services for client;

WHEREAS, Artist accepts to engage to perform make-up services (the "Service") to Client for the amount of _____;

NOW, WHEREFORE, FOR and in consideration of the foregoing premises, the Parties hereby agree as follows:

Time and Place

The Service shall be conducted beginning _____ and shall end at _____ (the "Event") at the following address:

Terms of Payment

Client shall pay _____ of the total contract amount and shall pay the remaining balance after completion of the Service.

Cancellation

In case Client cancels this Agreement _____ week prior to the scheduled event, all deposits made by Client to Artist shall be non-refundable. In case Client cancels this Agreement with more than _____ week from the scheduled event, a cancellation fee of _____ dollars shall be collected by Artist

Consultation

A trial makeup ("Consultation") may be availed of by Client at the latter's option. Consultation fee shall be separate and not included in the contract amount. This is a separate fee for the amount of _____ per person. Consultation may be availed of any time, but not later than _____ days prior to the day of Event.

Parking and Other Fees

Where parking, valet, airfare, accommodation, or other fees would be incurred by Artist, the amount shall be reimbursed by Client and shall be paid upon final payment, supplemented by receipts of payment.

Travel Fees

Travel from Artist's business address to the venue within twenty (20) miles is free of charge. However, where the travel of Artist to the venue is more than 20 miles from Artist's business address, an additional charge of one dollar (\$1.00) per mile shall be charged.

Image Use

Client allows that images captured by Artist and/or the latter's representative of Client may be used by the latter for use on websites, brochures, or for any purpose of advertising the works of said Artist.

Client does not allow that images captured by Artist and/or the latter's representative of Client may be used by the latter for use on websites, brochures, or for any purpose of advertising the works of said Artist.

Separability Clause

Should any provisions of this Agreement be held invalid or unenforceable by a competent Court, such invalidity or unenforceability shall only pertain to the said provision and the rest of the remaining provisions shall not in any way be affected or impaired thereby.

Confidentiality

The terms and conditions contained in this Agreement constitutes confidential information. The Parties agree to keep confidential such information against any third party unless written consent has been given by the other. In any event that a Party is legally compelled to disclose the confidential information of the other, such Party shall promptly notify the other in order for the latter to be able to afford protection or waive compliance with the provisions hereof. This provision shall survive the termination of this Contract for whatever reason.

Non-waiver

The non-demandability of the party to insist upon the compliance to any of the provisions herein shall not be deemed as a relinquishment or waiver to any of the terms, conditions, and covenants herein contained. No waiver by either party shall be deemed to have been made unless expressed in writing and signed by the waiving party.

Counterparts

This contract may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same contract.

Governing Laws

This Agreement shall be governed and construed in accordance with the laws of _____, without regard to other state laws and to its conflicts of laws provisions.
