



Manager Contract

This Manager Contract ("**Contract**" hereinafter) created and executed on the _____ day of _____, _____, by and between the following parties:

and

in connection with engaging Manager as Artist's manager for the development and enhancement of Artist's career.

1. TERM

This Agreement shall commence on the date of last signature below and remains valid and effective for _____. At the end of this period the Contract expires and shall automatically renew on a yearly basis thereafter unless this Agreement is terminated before its normal expiration date and/or in accordance with the provisions hereof.

2. MANAGER'S ROLES AND DUTIES

Manager shall be the sole and exclusive personal manager, advisor, and representative of Artist during the effectivity of this Contract. Such services shall include, but not limited to:

1. Artist representation in negotiations, disposition, engagement, and use of talent of Artist.
2. Supervise Artist on conduct and image maintenance as well as consult with business partners and employers in ensuring the maintaining the demand Artist by the public.
3. Schedule and manage the availability of Artist in business matters and interests, employment, and publicity activities.
4. Manage the promotion of Artist in all media events and platforms for purpose of advertising, publicity.
5. Manage the finance of Artist including the management of earnings made by the Artist.



3. ARTIST RESPONSIBILITY

It shall be the responsibility of Artist to engage and discharge theatrical agents, agencies for the purpose of securing contacts.

Artist agrees to not engage any other manager, representative, or agent, in rendering services that are contemplated to this Contract without the prior written consent of Manager.

4. COMPENSATION

Manager shall receive as a commission a sum equal to _____ percent of Gross Income from all engagements and agreements contemplated hereunder, reasonably related to Artist's career in the the management supervised by Manager, entered into or negotiated during the effectivity of this Contract, directly or indirectly.

5. FEES AND EXPENSES

Artist shall solely be responsible for fees, dues, and expenses relative to or arising from the performance of Manager in relation to the services provided herein this Contract. Advances made by the Manager for any and all reasonable expenses in connection with the Artist's career shall be properly reimbursed by Artist.

6. TERMINATION

The Artist reserves the right to terminate this Contract with immediate effect if the Manager engages in gross misconduct, willful neglect of duties, or breaches any material provision of this Contract or is found guilty of any criminal offense or any act that brings disrepute to the Artist.

Either party may terminate this Contract by providing _____ written notice to the other party. Upon termination, the Manager shall fulfill all duties and responsibilities up to the end of the notice period and cooperate in the transition of responsibilities as requested by the Artist.

6. ASSIGNMENT

Manager may assign any part of his/her duties and responsibilities or rights contemplated in this Contract only to a firm or corporation in which the Manager is a principal. Artist may not assign this agreement without Manager's consent in writing.



7. INDEMNIFICATION

The Parties hereto shall indemnify, defend, and hold harmless each other against any costs, claims, liabilities, damages, or causes of action suffered by the other arising from or in connection with or arising from any act or omission resulting to negligence or breach of the Contract.

8. SEPARABILITY CLAUSE

In the event that any of the provisions of this Agreement be held invalid by any competent court, the same shall apply only to the said provision, and the remaining provisions hereof shall remain valid and enforceable.

9. AGREEMENT MODIFICATION

Parties are prohibited from deviating from the provisions of this Contract. No modification or alteration of this Contract shall be considered as having been made unless otherwise executed in writing and duly signed by the parties hereto.

10. JUDICIAL ACTION

Any issue or controversy arising from or brought under this Contract shall be resolved with the proper courts of _____, to the exclusion of all other venues and without regard to conflict of laws.
