1. Introduction

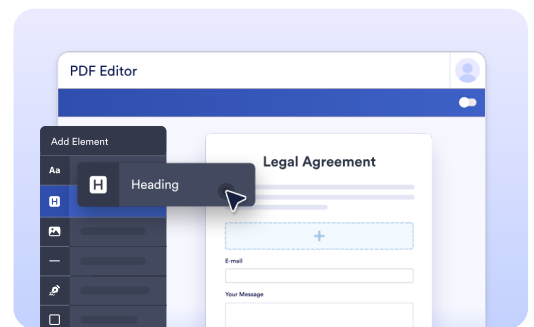

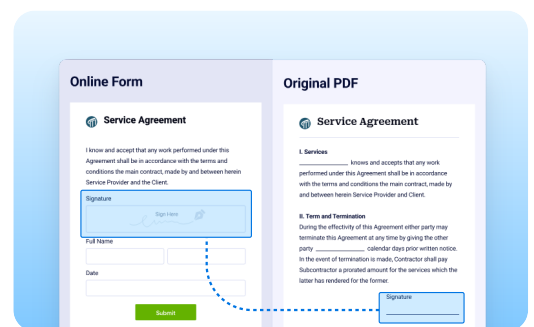
