

# Membership Agreement

## 1. Parties

This **Membership Agreement** (shall be referred as "**Agreement**" hereinafter) has been signed by and between the following parties;

## 2. Membership Details

The Organization hereby grants the membership of the Member, subject to the membership details outlined in the table below;

## 3. Membership Fees and Payment Procedure

Within the scope of this Agreement, the Member Agrees to pay \_\_\_\_\_ annually, as membership fee for his/her membership type. This amount includes all the services indicated in the table under Article 2 of this Agreement.

The payment of the membership fee shall be made in \_\_\_\_\_ equal installments, or in cash upon the signing of this Agreement. In case of cash payment, \_\_\_\_\_% discount is given.

In cases where the payment is made in installments, each installment is paid on the \_\_\_\_\_ day of each month at the latest. In the event that any of the installments are not received by the specified due date, the Organization reserves the right to impose \_\_\_\_\_ late payment penalty.

#### **4. Duration and Renewal of the Membership**

The membership term shall commence on \_\_\_\_\_ and continue for a period of 1 (one) year unless terminated in accordance with the termination provisions of this Agreement.

After the expiration of the initial membership term, the Member may have the option to renew the membership. To renew their membership, the Member shall submit a written renewal application to the Organization a reasonable time before the expiration . The Organization shall provide a renewal fee proposal to the Member 10 days prior to the expiration of the current membership term. If the Member accepts the proposed fee, membership continues under the same conditions.

To ensure continuity of membership benefits, the Member shall submit the renewal application and pay the renewal fees on time. Failure to renew by the deadline may result in a lapse of membership privileges.

#### **5. Right and Obligations of the Member**

- The Member shall have the right to access and use the facilities and services provided by the Organization in accordance with the terms of this Agreement and the membership level selected.
- The Member may participate programs organized by the Organization, subject to availability and any specific requirements or conditions.
- The Member's right to use is unlimited. The facilities and services may be used by the Member every day of the week and during the hours when the facilities are open.
- The Member shall receive information, updates, and communications from the Organization via email and other communication tools regarding events, activities, news, and relevant matters.

- The Member shall comply with the Organization's code of conduct, policies, rules, and regulations as established by the Organization's governing body. The Member is also obliged to comply with the general community rules and society's code of conduct. Otherwise, the Organization reserves the right to suspend or terminate the membership.

## 6. Termination

The Member may terminate this Agreement at any time, without giving a reason, by providing a written notice to the Organization. The termination shall be effective upon receipt of the notice by the Organization. In such a case, the Member shall pay undue installments on time.

If the Member fails to renew the membership in accordance with the renewal procedures outlined in this Agreement, membership shall automatically expire at the end of the membership term.

The Organization has right to suspend service or terminate the Agreement for cause, if the Member violates the code of conduct, policies or rules of the Organization. Prior to suspending or terminating the Member's membership, the Organization shall provide the Member a written notice specifying the reasons for the suspension or termination. This notice has an immediate effect.

Upon termination of membership, the identity card that allows the Member to enter the facilities is canceled.

## 7. Confidentiality

Within the scope of this Agreement, confidential information means any information related to the member, including but not limited to, name, contact information, financial information, health conditions, audio or visual records etc. The Organization agrees to treat all confidential information of the member as strictly confidential and to not disclose, share, or otherwise disseminate such information to any third party without the express written consent of the Member.

## 8. Miscellaneous Provisions

**Amendments** - Any amendments or modifications to this Agreement shall be made in writing and signed by both parties.

**Severability** - If any provision of this Agreement is found to be invalid, illegal, or unenforceable, such provision shall be deemed severed from this Agreement, and the remaining provisions shall remain in full force and effect.

**Notices** - All notices, requests, demands, and other communications required or permitted under this Agreement shall be in writing and shall be deemed to have been duly given if delivered personally or sent by registered mail, postage prepaid, to the addresses specified in this Agreement.

**Assignment** - Right and obligations of the parties arising from this Agreement shall not be assigned to any other third parties without prior written consent of the other party.

**Governing Law and Jurisdiction** - This Agreement shall be governed by and construed in accordance with the laws of \_\_\_\_\_. Any legal action or proceeding arising out of or related to this Agreement shall be brought in the courts of \_\_\_\_\_.
