4. The Tenant agrees to the following terms:

- The Tenant shall be responsible for the Pet(s) at all times,
- The Tenant agrees to keep the Pet from being noisy or aggressive and causing any annoyance or discomfort to others will remedy immediately any complaints made by the others,
- The Tenant agrees to have the pet under control at all times and exercise respective due care,
- The Tenant agrees to clean and remove all pet waste, inside or outside the Premises,
- The Tenant agree to keep the Pet in appropriate areas within the Premises and will not be left unattended for an undue amount of time,
- The Tenant shall comply with all applicable community association rules, statutes, local ordinances, rules and regulations.

7. The Tenant indemnifies or holds harmless the landlord against all liability, expenses, or claims for any accident or injury caused by the Pet to any person or property.

8. The Tenant agrees to remove the Pet immediately and permanently upon Landlord's written demand if the Landlord determines Tenant has violated any provision in this Addendum.

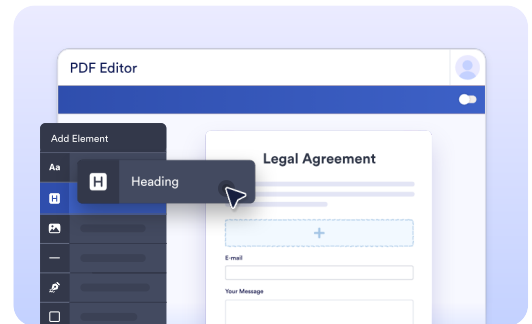

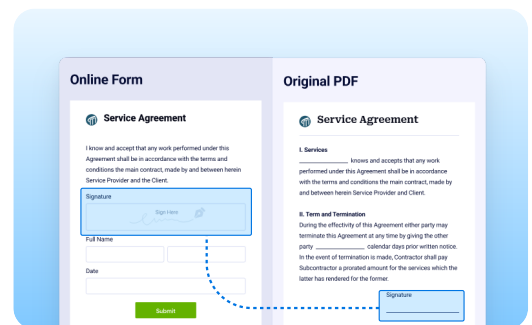

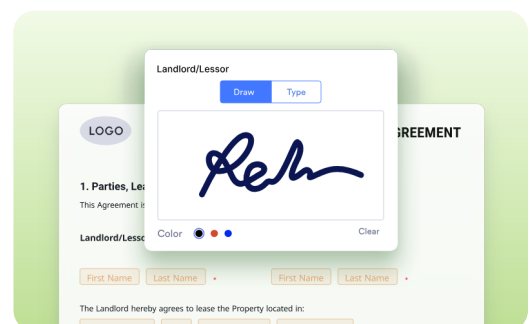
