Pet Sitting Agreement

This **Pet Sitting Agreement** ("**Agreement**") is entered into on _____ by and between the **Pet Sitter** ("**Sitter**") and the **Pet Owner** ("**Owner**") identified below, to set out the terms and conditions under which Sitter will provide pet sitting services for the Owner's pet during the period described below.

1. Pet Information

Owner warrants that the following details about the pet are accurate and complete:

2. Services to Be Provided

Sitter agrees to provide the following services during the agreed-upon period:

- Feeding and ensuring constant access to clean water.
- Walking/exercise at agreed intervals.
- Administering medications as instructed in writing by Owner.
- Cleaning litter boxes, cages, or other enclosures as applicable.
- Providing companionship and reasonable care.
- Monitoring for any signs of illness or distress.
- Immediate notification to Owner in case of emergency.
- Sitter is not authorized to provide grooming, training, or veterinary services unless explicitly agreed in writing.

3. Working Hours and Availability

Sitter agrees to provide services on a daily basis during the term of this Agreement. The standard arrangement shall include two (2) visits per day, approximately 30 minutes per visit, scheduled once in the morning (between 8:00 a.m. and 09:00 a.m.) and once in the evening (between 5:00 p.m. and 8:00 p.m.).

During each visit, Sitter shall perform the responsibilities stated in this Agreement. Sitter shall make reasonable efforts to adhere to the agreed schedule. However, Owner acknowledges that exact times may vary within the specified time ranges due to traffic, weather, or unforeseen circumstances. Unless otherwise agreed in writing, Sitter is not required to remain in the Owner's home overnight or outside the specified visit times.

Any request for additional visits, extended stay, or overnight care shall require prior agreement and may be subject to additional fees.

4. Term and Termination of Agreement

This Agreement shall commence on _____ and end on _____, unless earlier terminated. Any extension of services shall require written confirmation by both Parties.

Either Party may terminate this Agreement with _____ prior written notice. If Owner terminates this Agreement, payment for services already rendered remains due. In cases of emergency, misconduct, or unsafe conditions, Sitter may terminate immediately with notice to Owner.

5. Compensation

The Owner shall pay the Sitter _____ per _____ for services rendered. All payment under this Agreement shall be made on the

Additional costs such as food, medications, or veterinary expenses shall be reimbursed by Owner within 3 days of presentation of receipts.

5. Owner's Responsibilities

Owner agrees to provide sufficient food, supplies, medications, and equipment for the pet and provide accurate written instructions regarding feeding, exercise, medication, and behavior management. Owner also agrees to ensure that the pet is free from fleas, ticks, and communicable diseases, disclose any history of aggression, biting, or dangerous behavior and provide emergency contact details and ensure Sitter has access to the home during the service period.

6. Emergency Cases

In the event of illness or injury, Sitter is authorized to seek veterinary care at the nearest available clinic if the regular veterinarian cannot be reached. Owner shall be responsible for all veterinary fees and related costs. Sitter shall make reasonable efforts to contact Owner prior to treatment; if unreachable, Sitter may authorize necessary treatment in the Owner's best interest.

7. Liability and Indemnity

Owner agrees to hold harmless and indemnify Sitter from any claims, damages, or losses arising from the pet's behavior, illness, injury, or death, except where caused by Sitter's gross negligence or willful misconduct. Sitter shall not be liable for damage to Owner's property unless such damage results directly from Sitter's negligence. Owner remains fully responsible for any harm or injury caused by their pet to other persons, animals, or property.

8. Access to Owner's Property

Owner grants Sitter permission to enter the premises for the purpose of performing pet sitting duties. Owner is responsible for providing working keys, access codes, or other entry instructions. Sitter agrees to keep Owner's property secure and confidential and will not duplicate keys without written consent.

9. Confidentiality

Sitter agrees to maintain confidentiality regarding Owner's personal information, household details, and any sensitive matters learned in the course of performing services.

10. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of _____ . Any disputes shall first be attempted to be resolved through good-faith negotiation. If unresolved, disputes shall be submitted to mediation or arbitration before resorting to litigation.





