Service Schedule and Communication - In principle pool cleaning services shall be provided weekly, every _____ between _____. The Client and Contractor shall also mutually agree on a different weekly schedule for the period for cleaning of the above-mentioned pool, by which schedule shall be within Contractor's business hours (Monday-Saturday, 8:00 am-5:00 pm).

Service Package and Compensation - The cleaning service package that the Contractor provides includes the following;

Client agrees to pay the minimum amount of _____ weekly, on the day of service provision. Any additional demands of the Client shall be priced separately. Payments for maintenance and repairs is separate and shall be paid in accordance with the related clauses of this Contract.

Maintenance and Repairs - In case Contractor discovers anything in the subject swimming pool that is subject to repair or additional maintenance, it shall be discussed with Client with probable expense and malfunction period, unless such repair is urgently needed.

Client shall pay Contractor additional maintenance and repairs cost that may be required, which the Contractor shall invoice the Client for such work rendered.

Termination - Either party reserves the right to terminate this Contract upon providing written notice of _____ days in advance to the other party. Either party may also terminate this Contract immediately and without prior notice in the event of a material breach of Contract by the other party, including but not limited to non-payment, failure to perform obligations, or violation of terms outlined in this Contract.

Equipment and Standards - The Contractor shall use industry-standard equipment and tools necessary for the cleaning and maintenance of the Client's pool. This includes, but is not limited to, pool vacuum cleaners, brushes, skimmers, testing kits, and chemicals required for water treatment. The Pool Cleaning Service Provider shall comply with all applicable health, safety, and environmental regulations regarding the use and disposal of chemicals and waste generated during pool cleaning and maintenance.

Dispute Resolution - In case of dispute raised by either party with regard to any of the conditions set forth in this agreement, the parties will resolve such dispute amicably. In case of failure to resolve the dispute by amicable settlement, the parties shall resolve the matter by litigation. The losing party shall therefore pay the prevailing party any and all litigation costs other than the award of the dispute.

Applicable Law - This contract shall be construed and interpreted in accordance with the exclusive laws and rules of the state of _____ and relevant Federal Laws.
