# Pressure Washing Contract

## 1. Parties

This **Pressure Washing Contract** ("**Contract**") has been signed by and between the parties below;

## 2. Scope of Work

The Company will perform pressure washing services on the areas specified by the Client below;

The Company shall provide all necessary equipment, including pressure washing machines, hoses, and cleaning agents required to complete the work. ## 3. Payment Terms

#### **5. Termination**

Upon termination of this Contract, regardless of the reason for termination, the Client agrees to pay the Company for all pressure washing services performed up to the effective date of termination.

#### **6. Quality of Work**

The Company will utilize appropriate pressure washing techniques, equipment, and cleaning agents to achieve effective and safe results. The Company shall employ experienced and trained personnel to perform the pressure washing services.

The Company will exercise due care and take necessary precautions to avoid damage to the surfaces being cleaned or any surrounding property. However, the Client acknowledges that certain pre-existing conditions or vulnerabilities of the property may limit the Company's liability for any damage that may occur during the pressure washing services.

## 7. Confidentiality

The Parties acknowledge that the existence and the terms of this Agreement and any oral or written information exchanged between the Parties in connection with the preparation and performance this Agreement are regarded as confidential information. The Company and its employees are obliged to keep confidential all the information they have obtain, especially due to their presence in the place of work.

This article shall be severable if any of the provisions hereof are held by a court of competent jurisdiction to be invalid, void or otherwise enforceable.

## 8. Miscellaneous

- **Entire Agreement** - This Agreement represents the entire understanding between the parties and supersedes all prior negotiations, understandings and agreements between them.
- **Amendments** - This Agreement may not be amended or modified except in writing and signed by both parties.
- **Notices** - Any notice required to be given under this Agreement shall be in writing and shall be deemed to have been given upon personal delivery, mailing by above mentioned email, or postage prepaid to the addresses provided herein.
- **Governing Law** - This agreement shall be governed by and construed in accordance with the laws of the State of \_\_\_\_\_.

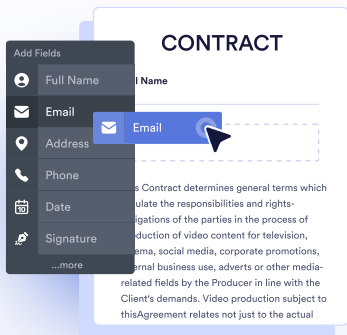

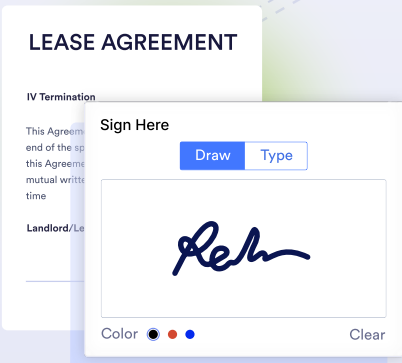
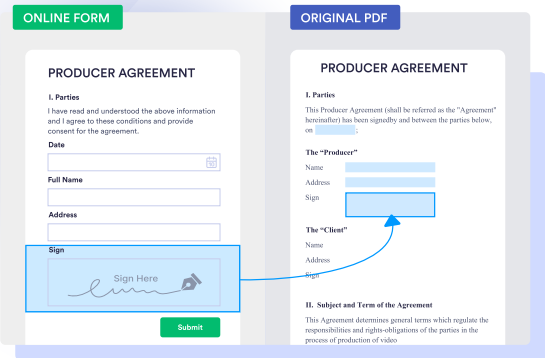
