

Private Investigator Contract

This **Private Investigator Contract** (shall be referred to as "**Contract**" hereinafter) has been signed by and between the parties below;

WHEREAS, the Client is in need of professional investigation services for

WHEREAS, the Private Investigator has necessary expertise, qualifications, and resources to perform the requested investigative services, and also has required licenses under applicable law,

WHEREAS, the Client desires to engage the services of the Private Investigator to conduct the investigation and the Private Investigator is willing to provide such in accordance with the terms and conditions set forth herein,

NOW, THEREFORE, in consideration of the premises and the mutual covenants contained herein, the parties agree as follows:

I. Objectives of the Investigation

The scope of the investigation shall be defined by the specific objectives outlined by the Client. These objectives may include, but are not limited to confirming suspicions of infidelity in marital or personal relationships, verifying the authenticity of claims made by individuals or entities, identifying and documenting evidence of fraud, theft, or other illegal activities and assisting in legal proceedings by providing investigative support and evidence gathering.

Main objective of the Client is defined below and any of the abovementioned methods shall be used to support the main objective of the investigation;

II. Scope of Work

The Private Investigator agrees to provide investigative services to the Client to achieve the objectives of the investigation. Within the scope of this Agreement, the Private Investigator is responsible for observing and documenting the activities and movements of individuals as requested by the Client and conducting research to verify the personal and professional history of individuals, including employment, education, criminal records, and financial background. While investigating, the Private Investigator shall use investigative techniques to find and locate individuals for various purposes, such as serving legal documents or reuniting with family members.

The Private Investigator shall perform the agreed-upon services within the scope of their expertise and in compliance with all applicable laws and regulations. The scope of work does not include activities that are illegal or unethical, including but not limited to trespassing, hacking, or unauthorized access to private information. The Private Investigator shall not engage in activities that could jeopardize their safety or the safety of others.

III. Term and Termination

The term of this Contract shall commence on _____ and shall continue in full force and effect until the completion of the services described herein or until terminated by either party in accordance with the terms herein.

This Contract is a agency contract that either party may terminate at any time upon _____ days written notice to the other party. In the event of early termination, the Client shall compensate the Private Investigator for any services performed and expenses incurred up to the date of termination, as specified in the payment terms herein.

Either party may terminate this Contract immediately upon written notice to the other party in the event of a material breach of this Contract by the other party that remains uncured after a reasonable cure period.

IV. Fee and Payment

The Client agrees to pay the Private Investigator hourly rate of _____ as retainer. The client shall be billed for the actual time spent by the private investigator on the investigation, rounded up to the nearest quarter-hour increment.

In addition to the service fees, the Client agrees to reimburse the private investigator for any reasonable and necessary expenses incurred in connection with the investigation such as travel expenses, accommodation, equipment rental, and third-party fees.

Invoices shall be submitted monthly and payment is due within _____ days of the invoice date.

Upon termination of the Contract for any reason, the Client shall pay any outstanding fees or expenses owed to the Private Investigator as of the date of termination in accordance with the payment terms.

IV. Confidentiality

For the purposes of this Contract, confidential information shall mean any and all information disclosed by either party to the other party, whether orally or in writing, that is designated as confidential or that reasonably should be understood to be confidential given the nature of the information and the circumstances surrounding its disclosure. Both parties agree to maintain the confidentiality of all confidential information disclosed during the course of the investigation. Each party shall use the confidential information solely for the purpose of performing its obligations under this Contract and shall not disclose such information to any third party without the prior written consent of the disclosing party. The obligations of confidentiality shall survive the termination or expiration of this Contract for any reason.

V. Other Provisions

- This Contract constitutes the entire understanding and agreement between the parties with respect to the subject matter hereof and supersedes all prior agreements, understandings, negotiations, and discussions, whether oral or written.
- No modification or amendment to this Contract shall be valid and effective unless it is in writing and signed by both parties.

- If any provision of this Contract is held to be invalid, illegal, or unenforceable, the validity, legality, and enforceability of the remaining provisions shall not in any way be affected.
- Neither party may assign or transfer its rights or obligations under this Contract without the prior written consent of the other party.
- This Contract may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
- This Contract shall be governed by and construed in accordance with the laws of _____ . Any dispute arising out of or in connection with this Contract shall be subject to the exclusive jurisdiction of the courts of _____ .
