



REMIX AGREEMENT

This **Remix Agreement** ("**Agreement**" hereinafter) has been sign by and between the parties below;

WHEREAS, Owner is the owner of certain copyrighted work, which is original work that can be described as _____ ("**Original Work**"),

WHEREAS, Remixer desires to create a derivative work based on the Original Work (the "**Remix**"),

WHEREAS, Owner is willing to grant Remixer a license to create and distribute the Remix, subject to the terms and conditions of this Agreement,

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties hereby agree as follows;

Scope of License - Owner hereby grants Remixer a non-exclusive license to create the Remix based on the Original Work, solely for the purpose of _____, and to reproduce, distribute, publicly perform, and publicly display the Remix as permitted by law.

Ownership - The Remix shall be considered a derivative work of the Original Work, and all rights, title, and interest in and to the Remix shall be owned by Owner, subject to the license granted to Remixer herein. The Owner has the right to reproduce, manufacture, advertise the Original Work and the Remix. The Owner has exclusive and unlimited right to the remix the Original Work.

REMIX AGREEMENT

Attribution - Remixer shall credit Owner as the original creator of the Original Work in any and all copies, reproductions, and distributions of the Remix, in a manner acceptable to Owner.

Compensation - Remixer agrees to pay Owner _____ as consideration for the license granted herein. The Owner shall also be paid _____% royalties in terms of record sold, media used in different media outlets and other related events wherein the remix will be used. Payment shall be made by _____.

Indemnification - Remixer agrees to indemnify, defend, and hold harmless Owner from and against any and all claims, damages, liabilities, costs, and expenses arising out of or related to the Remix or Remixer's breach of any provision of this Agreement.

Amendments - Changes or amendments to this contract require approvals from both parties involved.

Governing Law - This Agreement shall be governed by and construed in accordance with the laws of the State of _____.

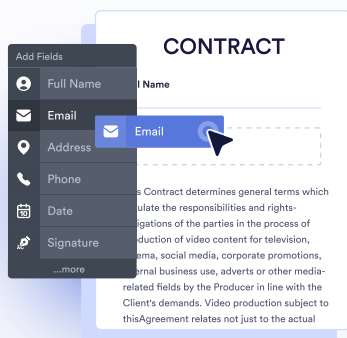

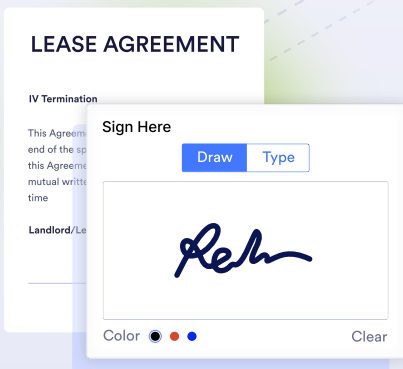
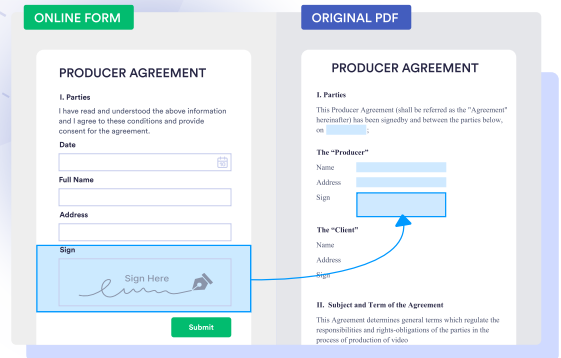
