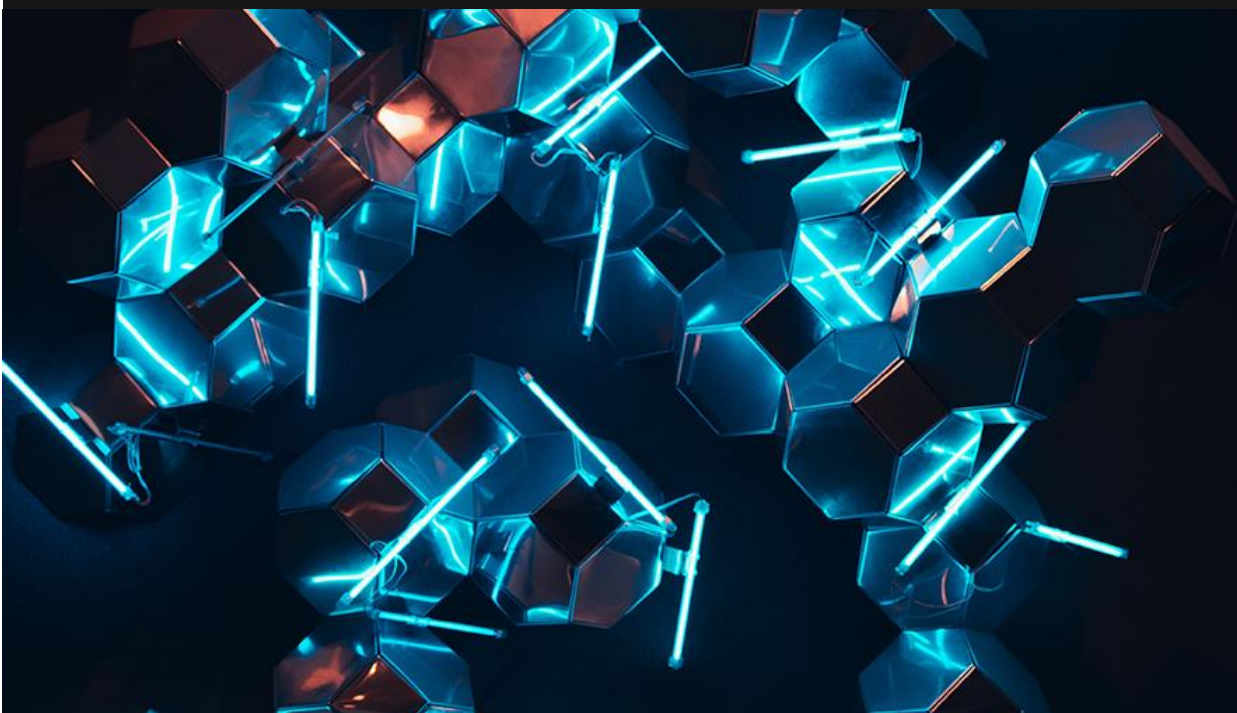

TERMS & CONDITIONS

I. Parties

This Security Proposal is specially prepared for _____
(the "**Client**" hereinafter) by ABC Security Company (the "**Company**" hereinafter).

If the Proposal is approved, it will be accepted as an Agreement between the parties and terms and conditions set out below shall be binding between the Client and the Company.

The Company shall provide security services by assigning security personnel in order to ensure security in the areas to be determined by the Client.

II. Term and Termination

The Agreement between the parties shall enter into force on the date of approval of the Client and the term of the Agreement is _____. Unless one of the Party gives written notice of the termination of the Agreement 15 days before the end of the term at the latest, the Agreement is deemed to be extended for 1 year with the same conditions. This procedure is also valid for the following years.

Parties may terminate the Agreement anytime with written agreement by deciding the term and conditions of the termination.

III. Price and Payment Schedule

Total service fee for this Agreement is _____. Payments shall be made on a monthly basis and _____ equal installments. Each installment shall be paid on the _____ day of the month at the latest. Payments shall be made by _____.

IV. Security Personnel

In principle, the security personnel shall be assigned by the Company. If the Client requests replacement, the Company may provide a list of available personnel if any. If there is no available security personnel, the Company may reject the request. Refusal of the request does not give the customer the right to terminate this contract, unless there is a valid reason.

Regardless of whether the personnel is appointed by the Company or the Client, the Company is solely responsible for all financial rights of the security personnel.

V. Right and Obligations of the Parties

- The Company is responsible for informing security personnel about the job description, discipline procedure and ensures that personnel performs the work in accordance with the scope of the service.
- Security personnel is responsible for ensuring general security and peace within the area of its responsibility. In this context, the personnel shall regularly monitor the security cameras during working hours and perform identity checks of the guests entering the area.
- The Client shall be entitled to supervise the security personnel during the shift. Working hours shall be determined by the Client and cannot exceed _____ hours per week. Security personnel must be given a break to rest.
- The Company is responsible for the annual leave days of the security personnel. However, permission requests shall be immediately notified to the Client on the date of request, and new personnel shall be appointed if the customer requests it in writing. In the absence of a written request, the Client remains liable to pay the full price.

VI. Confidential Information

Any sensitive or proprietary information that the Parties may acquire from each other through the course of this agreement shall be considered as Confidential Information. The Party acquiring the said confidential information shall keep confidential the confidential information and shall exercise the degree and care as required by the law.

VII. Miscellaneous Provisions

- This Proposal shall only be changed or modified by the Company. After the approval of the Client, the Agreement shall only be changed or modified with the written consent of the parties hereto.
- The failure of any party to insist upon the strict compliance with and performance of any of the terms, conditions, and covenants shall not be deemed as a waiver of said party may have over such breach. Only by expressed written consent and duly signed by the parties may a proper waiver be considered as having been made.
- Should any provision of this Agreement be held invalid by any competent court, the same shall apply only to the provision involved and the remaining provisions hereto shall remain valid and enforceable.
- This Proposal and the Agreement shall be construed and interpreted in accordance with the federal laws and the laws of the State of _____.
