NOW, THEREFORE, for and in consideration of the foregoing premises, and of the mutual covenants, agreements, and promises set forth herein, the parties, intending to be legally bound, agree as follows:

Scope of Services

The Contractor hereby agrees and undertakes to provide following services ("Services" hereinafter) within the scope of this Agreement;



Term of Agreement

The term of this Agreement is _____, starting from _____ and all the services shall be fulfilled on _____ at the latest. If the Contractor cannot complete the work undertaken within this period, one-time extension may be requested by the Contractor. Extension period does not exceed one month.

Compensation

The Client shall pay the Contractor the fixed price total amount of _____ U.S. Dollars in a/an _____ basis. _____% interest rate shall be applied to any late payments. In case of late payment, the Contractor may suspend this Agreement and may terminate the Agreement with _____ days prior notice.

It shall be the sole responsibility of Contractor to file and pay for taxes arising out of the Contractor's earnings arising from this Agreement, including but not limited to, federal and state income taxes, and other governmental contributions.

No Employer-Employee Relationship

Client and Contractor understand and agree that the Parties are independent contractors and nothing herein shall be construed to create or imply that there is a partnership, joint venture, employee-employer relationship or other combined business organization between the parties. The Parties hold no authority to commit, oblige, make representations on behalf of each other, whether express or implied.

Confidentiality

Any information not considered as public information that Contractor may acquire through the course of this Agreement shall be recognized as Confidential Information. The Contractor shall keep confidential the confidential information and shall exercise the same degree of care required by law.

Separability

Should any provision of this Agreement be held invalid by any competent court, the same shall apply only to the provision involved and the remaining provisions hereto shall remain valid and enforceable.



Amendments

No modification or alteration of any kind in this Agreement shall be considered as valid and enforceable unless such modification or alteration is agreed upon and signed by the parties hereto.

Governing Law

This Agreement shall be governed by and construed in accordance with and only of the laws of the State of _____.

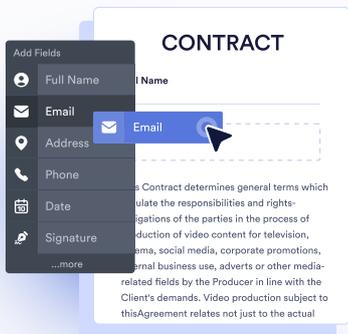



