Terms & Conditions

The purpose of this Contract is to outline the terms and conditions under which the Player will participate in the training and development programs offered by the _____ ("Club" hereinafter).

Registration Fee

Medical Consent

The Parent/Guardian consents to the Player receiving medical treatment in case of injury or illness during training or matches. The Parent/Guardian releases the Club, its coaches, staff, and volunteers from any liability arising from injuries or illnesses sustained during training or matches, except in cases of gross negligence or intentional misconduct.

Training

The Club agrees to provide the Player professional soccer training, including regular training sessions, physical conditioning and participation in matches and tournaments. The training schedule and program details will be provided by the Club and may be subject to change. Changes shall be notified by the Club at least _____ before the new schedule.

If the Player misses scheduled matches or training sessions without a valid excuse, the Player cannot request a make-up session or a partial refund.

Injuries

In case injury occurs and Player is unable to play for a period of more than 8 weeks or more, Player shall be withdrawn from the season. Payments made shall be refunded with 20% deduction from the total amount of fees for the season.

⚽ Code of Conduct

Players shall maintain good conduct and sportsmanship in respecting the rules, the officials, and their decisions. Any actions by Player to the contrary shall be met with penalties including but not limited to damages or expulsion.
