



# Television Broadcast License Agreement

**DEFINITION:**

Free Television shall mean analog, non-interactive transmission over UHF or VHF of synchronized audio and video signals originating in the Territory for analog reception on standard television receivers by standard television antennae.

The following are not included under the concept of Free Television: pay-per-view, home video, internet, cable, digital streaming, or internet-based technology.

**LICENSE:**

Subject to the compliance by the Licensee of the requirements with all other provisions and restrictions set forth herein, Licensor grants Licensee an exclusive license ("License") for the Television exhibition of the Programs on the channel and territory wherein Licensee is authorized to exhibit during the effectivity of this Agreement.

**TERRITORY:**

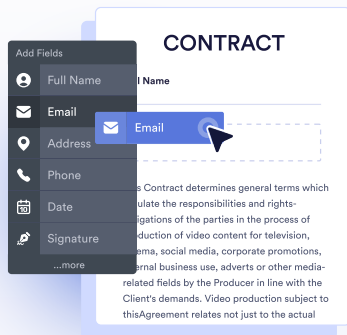

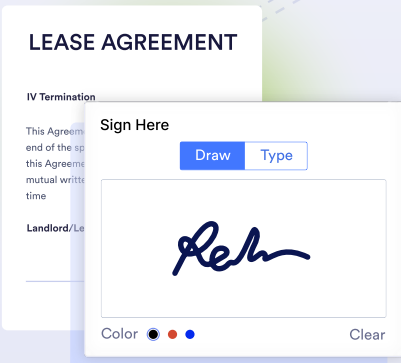
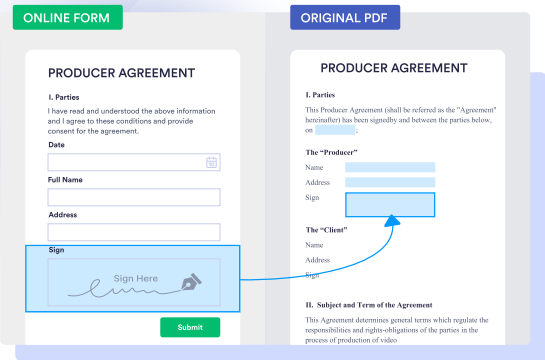
