



TERMS OF USE

I. Introduction and Acceptance of Terms

These **Terms of Use** ("**Terms**") govern access to and use of the website, platform, application, or online service operated by _____ ("Company," "we," "us," or "our"), including all related content, features, functionality, products, and services (collectively, the "Service").




