Transfer of Copyright

The Publisher cannot make any changes to the original manuscript.

Compensation

The Author and the Publisher agrees that the Author shall be paid royalties at the rate of _____% of the net sales of the Work, monthly. Payments shall be made within the first 10 days of the following month. No advance payment shall be applicable to the Author.

Rights of the Author

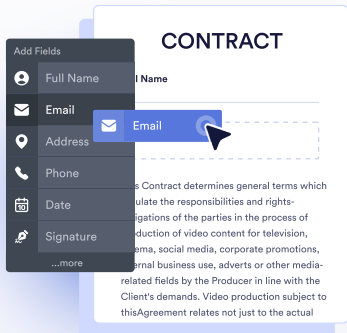

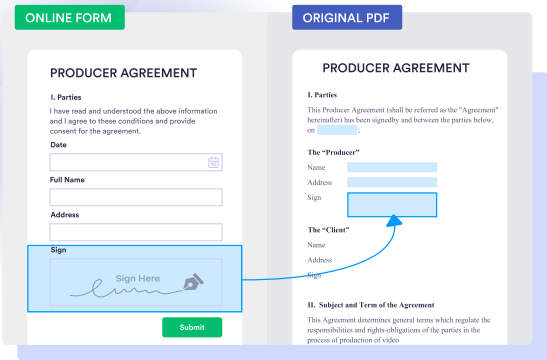

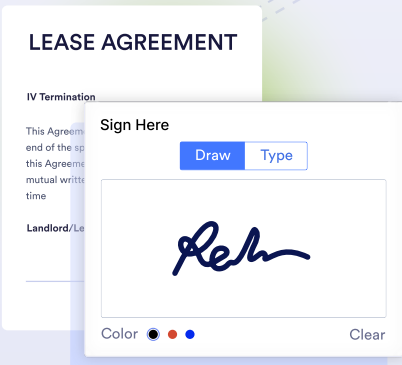
