



Uncontested Divorce Agreement

This **Uncontested Divorce Agreement** ("**Agreement**") is made on _____, by and between the parties below:

Party A and Party B may be referred to individually as a "**Party**" and collectively as the "**Parties.**"

1. Purpose

The purpose of this Agreement is to set out the full and final understanding between the Parties regarding the terms of their separation and divorce, including division of property, financial matters, and any other relevant arrangements. The Parties intend this Agreement to reflect a mutual and voluntary resolution of all issues arising from their marriage.

2. Marital Background

The Parties confirm that:

6. Debts and Liabilities

The Parties agree to the allocation of debts as follows:

7. Spousal Support

Neither Party shall pay spousal support to the other. Each Party acknowledges that they are financially independent or capable of becoming self-supporting.

8. Tax Matters

The Parties agree that:

- Any joint tax obligations incurred during the marriage shall be addressed as follows:

9. Full Disclosure

Each Party confirms that they have made a full and honest disclosure of all assets, liabilities, income, and financial circumstances. This Agreement is entered into based on that disclosure.

10. Mutual Release

Each Party releases the other from any claims, demands, or obligations arising from the marriage, except as expressly set out in this Agreement.

11. Voluntary Execution

Each Party confirms that:

- They have read and understood this Agreement.
- They have entered into it voluntarily and without coercion.
- They have had the opportunity to seek independent legal advice before signing.

12. Governing Law and Dispute Resolution

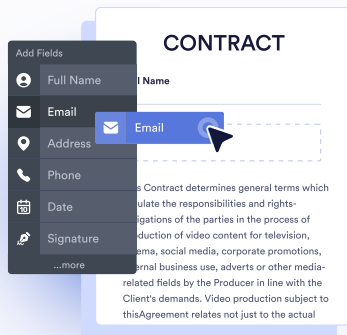

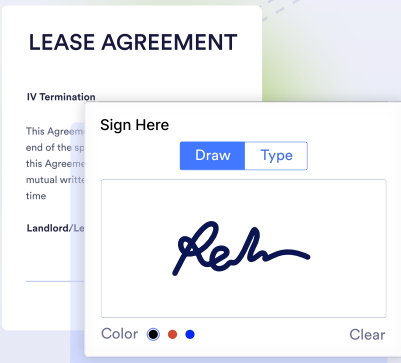
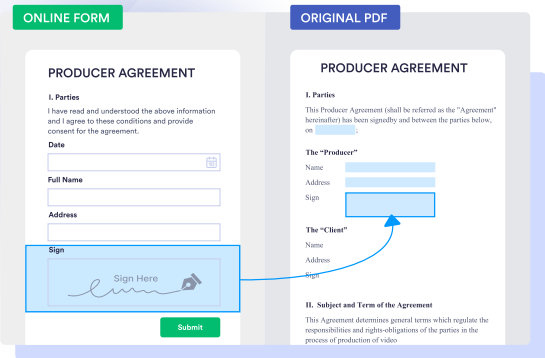
