



# Visitation Agreement

This **Visitation Agreement** ("**Agreement**") is entered into as of \_\_\_\_\_, by and between the following parties:

Parent 1 and Parent 2 are referred to individually as a "**Parent**" and collectively as the "**Parents.**"

## 1. Purpose and Intent

The purpose of this Agreement is to establish clear, practical, and consistent visitation arrangements for the benefit of the minor child(ren) identified below. The Parents enter into this Agreement voluntarily, with the shared intent of supporting the child(ren)'s well-being, stability, and ongoing relationship with both Parents.

This Agreement is intended to set out mutually agreed visitation terms and does not replace or modify any court order unless expressly approved by a competent authority.

## 2. Child Information

This Agreement applies to the following minor child(ren):

## 3. Legal Custody and Parenting Authority

Unless otherwise agreed in writing or ordered by a court, the Parents acknowledge that each retains their respective parental rights and responsibilities. This Agreement governs visitation time only and does not, by itself, determine legal custody, decision-making authority, or child support obligations.

#### **4. Regular Visitation Schedule**

Visitation shall occur according to the following schedule:

##### **Regular Parenting Time**

The non-residential Parent shall have visitation with the child(ren) on:

Visitation shall begin promptly at the scheduled start time and conclude promptly at the scheduled end time unless otherwise agreed in advance.

#### **5. Holiday and Special Occasion Schedule**

Holiday and special occasion visitation shall take priority over the regular visitation schedule unless otherwise stated.

The Parents agree to the following arrangements:

#### **6. Vacation and Extended Time**

Each Parent may take vacation or extended visitation time with the child(ren) as follows:

Vacation plans shall not unreasonably interfere with the child(ren)'s schooling, health care, or previously agreed commitments.

#### **7. Transportation and Exchanges**

Transportation responsibilities shall be as follows:

Both Parents shall ensure that exchanges occur respectfully and without exposing the child(ren) to conflict.

## **8. Communication with the Child**

During periods when the child(ren) are with one Parent, the other Parent shall have reasonable communication access through phone, video call, or electronic messaging, provided such communication is appropriate, not excessive, and respectful of the child(ren)'s routine.

## **9. Parental Conduct and Cooperation**

Each Parent agrees to:

- Act in the best interests of the child(ren)
- Refrain from speaking negatively about the other Parent in the presence of the child(ren)
- Support the child(ren)'s relationship with the other Parent
- Comply with the visitation schedule in good faith

## **10. Modifications**

This Agreement may be modified only by a written document signed by both Parents. Temporary adjustments made by mutual consent do not permanently alter this Agreement unless confirmed in writing.

## **11. Missed or Cancelled Visitation**

If visitation is missed or cancelled, the Parents shall make reasonable efforts to reschedule when appropriate. Repeated or intentional interference with visitation may require further discussion or formal resolution outside this Agreement.

## **12. Governing Law**

This Agreement shall be governed by and interpreted in accordance with the laws of \_\_\_\_\_, without regard to conflict-of-law principles.

## **13. Entire Agreement**

This document represents the entire visitation agreement between the Parents concerning the subject matter addressed herein and supersedes any prior written or verbal understandings regarding visitation.

## **14. Acknowledgment and Voluntary Agreement**

Each Parent acknowledges that they have read this Agreement, understand its terms, and enter into it voluntarily and in good faith, believing it to be in the best interests of the child(ren).

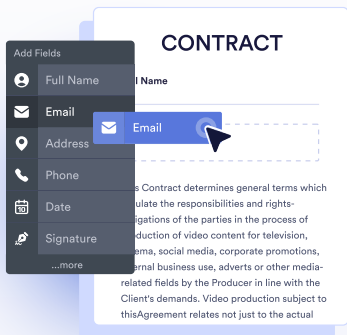

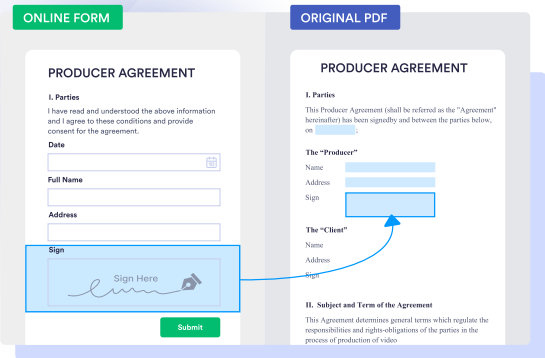

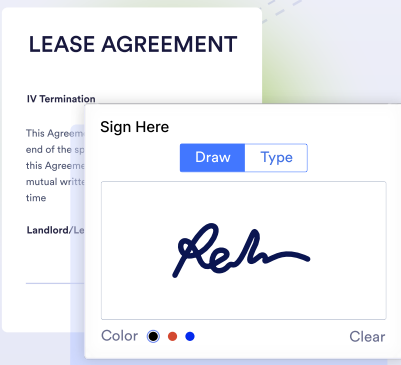
