The Client or a designated representative must ensure that the venue is accessible and available for the setup at the scheduled time. The Pastry Chef will not be held responsible for any damage to the cake after setup is complete.
- While every effort will be made to replicate the agreed-upon design, the Pastry Chef cannot guarantee an exact match due to variations in handcrafted elements and natural materials used in decorations.
- In the event of unforeseen circumstances, the Pastry Chef shall make reasonable efforts to deliver the cake but cannot be held responsible for non-delivery or delays caused by such events. If delivery cannot be made for reasonable causes, the deposit shall be refunded and the Pastry Chef cannot claim balance due.
- The Pastry Chef reserves the right to photograph the wedding cake for promotional purposes, including but not limited to the Pastry Chef's website, social media, or marketing materials. The Client grants permission for the cake images to be used for promotional purposes.
- In the event of cancellation by the Client, the deposit is non-refundable. Cancellations made _____ before the wedding date may still require payment of the balance due, depending on the circumstances and work completed by the Pastry Chef.
