The officiant will not be responsible for any injury, damages, or loss caused by the client or guests. The officiant will also not be liable for any loss during the event.

INDEMNIFICATION

The client agrees to defend and hold harmless the officiant and its employees for any injury, liability, damage to property, or claims to the actions of the client.

SEVERABILITY

Any provision found in this Wedding Officiant Contract shall be held illegal, invalid, or unenforceable by any competent court, the same shall apply only to the provision and the rest of the remaining provisions hereto shall remain valid.

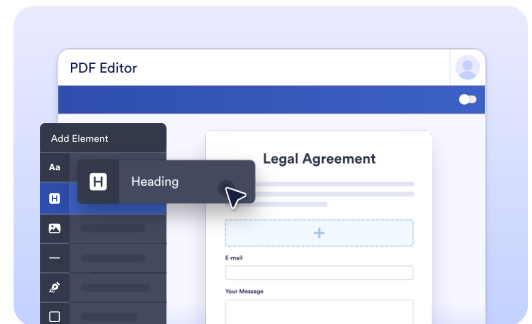

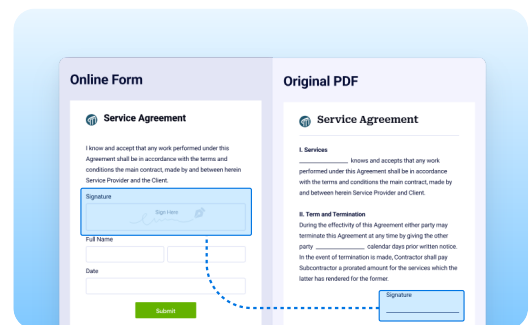

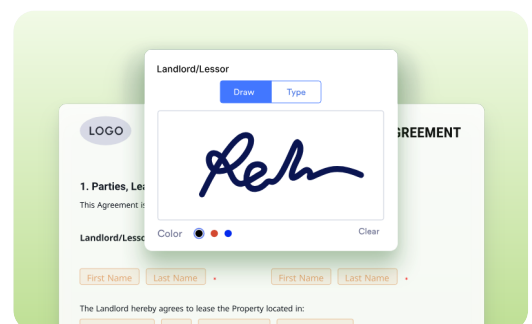
